However, after having heard the learned counsel, as well as, learned P.O. it appears to us that the stand of the respondents must come on record in regard to the issue raised in the O.A. so that some effective decision can be taken in the matter. We, therefore, direct the respondents to file affidavit in reply on or before 13.03.2023 with relevant documents in support of their contentions.

2. Present Misc. Application has been filed by the intervenors, who have now been added as respondent Nos. 4 & 5 in the O.A. No. 932/2023, seeking modification of the interim relief granted in O.A. or to suitably modify the said relief so that it shall not come in way of issuance of appointment orders in their favour. (These applicants are hereinafter referred to as Respondent nos. 4 & 5)

3. Shri Avinash S. Deshmukh, learned counsel appearing for respondent Nos. 4 & 5 submits that

respondent no. 04 had applied from E.W.S. Female category, whereas respondent no. 05 had applied from O.B.C. Female category. Learned counsel pointed out that since both these respondents scored higher number of marks their selection has been shown against the seats meant for Open Female category. Learned counsel pointed out that for Open Female 41 posts were reserved and respondent nos. 4 & 5 are at sr. nos. 40 and 41 in the said list. Learned counsel pointed out that despite having their names in the list of the recommended candidates, the appointment orders have not been issued in their favour because of the interim order passed by this Tribunal in this O.A. Learned counsel, in the circumstances, prayed for modification of the interim order.

4. Request so made has been resisted by the applicants. Learned counsel for the applicants submitted that the original applicants have scored more marks than respondent nos. 4 & 5 and, as such, applicants have better claim on the seats reserved for Open Female candidates. Learned

counsel submitted that in view of G.R. dated 4.5.2023 since the requirement of filing on record the Non-Creamy Layer Certificate is dispensed with, the original applicants are having good chance of their selection against the Open Female category on their own merits and considering the said aspect this tribunal has rightly directed the respondents to keep 02 seats vacant. Learned counsel in the circumstances has opposed the request made by respondent nos. 4 & 5.

5. Learned Presenting Officer has supported the submissions made by the applicants in O.A. Learned P.O. submitted that though yet the applicants have yet to establish their claim having regard to the fact that they have secured more meritorious position than respondent Nos. 4 & 5 there appears no reason for modification of the order at the instance of such candidates. Learned P.O. also has therefore, prayed for rejecting the request of respondent Nos. 4 & 5.

6. Responding to the submissions made on behalf of the applicants and on behalf of the State

authorities, the learned counsel for respondent nos. 4 & 5 invited our attention to the short affidavit filed by these respondents. The learned counsel pointed out that in the said affidavit the latest information is made available as about the seats filled in and the seats, which have remained unfilled. The contents of the affidavit reveal that total 298 posts were published and the appointment orders have been issued in favour of 287 candidates. Thus 11 posts have not been filled yet. Out of those 11 posts, 02 posts are kept vacant as per the interim order dated 19.10.2023 passed by this Tribunal. Out of remaining 09 posts, 03 candidates, who are at sr. nos. 18, 50 & 185 in the list of recommended candidates belonging to Open, O.B.C. and N.T.C. (Female) category respectively and who have been recommended against the seats reserved for Open General, Open General and N.T.-C Female respectively, had not remained present for documents verification. As such, appointment orders are not issued in their favour. The affidavit further provides that, out of remaining 06 candidates, 01 candidate at sr. no. 285 belonging to

S.C. Female Locomotor Disabled Category though was liable to be recommended against the seat reserved for P.W.D. category, did not show any interest in accepting the appointment and that post also has not been filled in. Out of 05 posts while 03 posts were earmarked for PWD Category and remaining 02 posts are earmarked for Orphan Category. As mentioned in the said affidavit insofar as 05 posts are concerned, no candidate has become available for selection and those seats have remained unfilled.

7. Shri Deshmukh, learned counsel submitted that as per the Government policy, if the candidates do not become available for the seats reserved for Orphan category, the said seats are released from that reserved category and are converted into the Open seats. Referring to the aforesaid factual data the learned counsel submitted that the interim order passed in the O.A. be suitably modified so that the respondent nos. 4 & 5 are not deprived from getting the appointment.

8. From the documents on record respondent nos. 4 & 5 are indisputably shown to have been recommended for their appointment against the seats reserved for Open Female candidates. Respondent nos. 4 & 5 respectively belong to E.W.S. Female and O.B.C. Female category. However, since both these candidates have secured the meritorious position and scored more marks than the candidates, who had applied from Open Female category that their selection has been made in order of their merit against the Open Female seats. It is also undisputed that both the original applicants have scored more marks than respondent nos. 4 & 5 and more importantly the original applicants belong to Open Female category. Considering the fact that both the applicants had secured more meritorious position than the last 02 candidates recommended against the Open Female seats, the interim order has been passed directing the respondents to keep 02 posts unfilled.

9. It is the matter of record that the said last 02 candidates are respondent nos. 4 & 5. In view of the

interim order, said candidates have not been therefore given appointments against the said posts. It is, however, discernable that while withholding the appointments of respondent nos. 4 & 5 the respondents have lost site of the fact that respondent nos. 4 & 5 have secured the highest position in their respective categories i.e. E.W.S. Female and O.B.C. Female category. In the circumstances, even if it is assumed that the O.A. is allowed and the original applicants are directed to be given appointments against the last 02 seats meant for Open Female candidates against which presently the names of respondent nos. 4 & 5 have been recommended, at the most the respondent nos. 4 & 5 will be shifted from the said Open seats, but will not be out of race and both the candidates being highest scorer in their respective categories, they will have to be shifted to their respective categories. It is thus evident that in none of the contingencies the respondent nos. 4 & 5 are likely to lose the appointment.

10. For the reasons discussed above, we are convinced that respondent nos. 4 & 5 have certainly made out a case for accepting their prayer made in the present Misc. Application. The question arises what relief can be given to these candidates at this interim stage? In this regard, we will have to revert back to the factual data provided in the additional affidavit in reply filed by respondent nos. 4 & 5. As has been elaborated in the said affidavit, the contents of which we have discussed in paragraph no. 06 of the present order, in view of the fact that the candidates at sr. nos. 18 and 50, who both have been recommended against Open General seats, when had not joined, these 02 seats may become available in Open General category, as well as, if the candidates in Orphan category if do not become available, 02 seats reserved for them would also be available for Open category candidates. From the details narrated above, it prima-facie appears that, probably there may not be any difficulty in issuing appointment orders to both the applicants, as well as, respondent nos. 4 & 5, if the Original Application

is allowed. In the facts and circumstances as above, we deem it appropriate to pass the following order:-
