2. Since the identical facts are involved, I have heard both these M.As. together and I deem it necessary to pass the common order in both these matters.

3. By filing the present Misc. Applications the applicants are seeking condonation of delay occasioned in filing the accompanying Original Applications by them.

4. In the Original Applications the applicants have sought relief for grant of one annual increment in their favour, which fell due on the next day after their retirement in the respective year of their retirement. Learned counsel for the applicants submitted that the Division Bench of Hon'ble Madras High Court in

W.P. No. 15732/2017 (P. Ayyamperumal Vs. The Registrar, Central Administrative Tribunal and Ors.)

decided on 15.09.2017 held the Government employees entitled for the annual increment payable on 1st of July who retired on 30th of June of the said year and only thereafter the Government employees who had retired on 30th of June started claiming the annual increment falling due on the next day of their retirement i.e. 1st of July of their retirement year. Learned counsel submitted that the applicants being retired way back in the year 2010 and residing in the remote area, came to know about the present legal position late and therefore, delay was caused in making representation with the Government. First representation was made on 04.10.2021 and thereafter reminder was given on 17.11.2021 and since there was no positive response from the Government, applicants have approached this Tribunal. Learned counsel submitted that the reasons assigned are genuine and bona-fide. Learned counsel in the circumstances prayed for condonation of delay in both these Misc. Applications.

5. Shri I.S. Thorat, learned Presenting Officer has opposed for condoning the delay stating that huge delay of more than 11 years has not been appropriately explained. Learned P.O. submitted that the applicants

did not raise any grievance or raise any claim in this regard till the date of filing of these applications from the date of their retirement. As such, the applicants cannot be said to be diligent in prosecuting their claim. He therefore, prayed for rejecting the present Misc. Applications.

6. I have duly considered the submissions made by the learned counsel for the applicants and learned Presenting Officers appearing on behalf of the respondent authorities. Learned counsel for the applicants has relied upon the judgment of Division Bench of the Hon'ble Bombay High Court, Bench at Aurangabad in **W.P. No. 14632/2021 (Balaji mankrao Biradar Vs. State of Maharashtra and Ors.)** with connected W.Ps. delivered on 04.05.2022. Learned counsel for the applicants more particularly invited my attention to para No. 11 of the said judgment, wherein the Hon'ble High Court has observed thus :-

“11. It is quite apparent that the judgment delivered by the Madras High Court in P. Ayyamperumal (supra), became a cause for these petitioners to approach this Court. None of them had challenged the non-inclusion of the annual increment in their pensionary benefits for calculation purposes, when they superannuated on 30th June of a particular year. As the judgment delivered in P. Ayyamperumal (supra) became known to all, that these petitioners have approached this Court. Some of the petitioners have superannuated in between 2016 and 2021.”

7. As observed by the Hon'ble Bombay High Court the cause of action for filing applications by the present applicants it can be said to have arisen in the year 2017 when the judgment by the Hon'ble Madras High Court was pronounced. If the delay is reckoned from the said date, it is of period of 4 years and some odd period. The applicants have assigned sufficient reasons explaining the said delay. Moreover, as has been further observed by Division Bench of the Hon'ble Bombay High Court in the aforesaid W.P., the consequential monetary benefits can be restricted for the period of preceding 3 years from the date of filing of the applications by the applicants. I am therefore, inclined to allow the present Misc. Applications. Hence, the following order :-

ORDER

- (i) M.A. Nos. 300 and 301 both of 2022 are allowed.
- (ii) Delay caused in filing accompanying O.As. is condoned.
- (iii) Accompanying O.As. be registered in accordance with law.
