Learned Advocate for Applicant emphasizes that there is only partial implementation of the provisions of 'Section 2(y)' and 'Section 20(2)' of 'The Rights of Persons with Disabilities Act 2016' regarding 'Reasonable Accommodation' by 'Revenue & Forest office of 'Special Deputy Department'; as Superintendent of Land Records and Enquiry Officer, Mira-Bhayandar, District Thane' is located on 'Third Floor' of 'Office Building' which has no 'Lifts'. Hence, it would be equally inconvenient for Applicant who has 'Benchmark Disability', as it is even now when serving on post of 'Deputy Superintendent of Land Records' at 'Tala, District Raigad'.

4 Learned Advocate for Applicant then stated that Applicant has mentioned all these facts in his representation dated 29.07.2024 to 'Joint Secretary, Revenue & Forest Department' requesting for modification of transfer from post of 'Special Deputy Superintendent of Land Records and Enquiry Officer, Mira-Bhayandar, District Thane' to post of 'Deputy Superintendent of Land Records; Shahapur, District Thane'.
