#### ORDER

(A) The Original Application is allowed.

- (B) The Respondents are directed grant retiral benefits to the Applicant by treating his date of superannuation as 31..01.2009 and shall grant all other consequential benefits to him as per his entitlement.
- (C) All monetary benefits as well as retiral benefits be accordingly released within six weeks from today.
- (D) The Applicant is at liberty to make an application to the Respondent No.1 for grant of interest on delayed retiral benefits, which will be dealt with in accordance to Rule 129(A) and (B) of M.C.S. (Pension) Rules, 1982.
- (E) The Applicant is entitled to cost of Rs.20,000/- from the Respondents jointly and severally."

4. Thus, O.A.No.916/2018 was filed for retiral benefits. The Applicant attained superannuation on 31.01.2009 but he was deprived of retiral benefits for ten years. During the pendency of O.A., the Tribunal has passed several interim orders giving directions to the Respondents to consider the name of the Applicant in view of the decision of the Hon'ble Supreme Court in (2003) 4 SCC 524 (Kunal Singh Vs. Union of India) in reference to Section 47 of Persons with Disabilities (Equal Dpportunities, Protection of Rights and Full Participation) Act, 1955. However, no such steps were taken and ultimately the Tribunal has decided the O.A. on merit. It is in that context having noticed inaction and lethargy on part of the Respondents the cost of Rs.20,000/- was imposed.

5. If the Government felt aggrieved against the order passed by this Tribunal, it could have challenged it before appropriate forum or ought to have filed Review. However, they have not challenged the judgment. It is only after four months period, these two Misc. Applications are filed to recall the order of imposition of cost. The cost is imposed to compensate the Applicant having noticed inaction on the part of the Respondents. I therefore, see no reason to recall the order of cost.

6. Misc. Applications are accordingly dismissed with no order as to costs.
