However, no such steps were taken as mandated in rules.
 - 4. On the contrary, the perusal of Affidavit in Reply reveals that the service book was sent on 02.08.2019 i.e. only before six months of retirement which ought to have been sent before two years of the retirement.
 - dispute about pensionable pay and entitlement for benefit of 10/20/30 years benefit of ACP in terms of G.R. dated 02.03.2019. Therefore, the department has sought guidance from the Respondent No.1- Additional Chief Secretary, Home Department as seen from letter dated 11.11.2022. However, no further steps are taken by the Home Department in the matter. Thus, the Respondent No.1 seems to be sitting over the matter though the period of near about 3 years is now over from the date of retirement of the Applicant.
