2. The grievance of the applicant in the present Original Application is that the M.P.S.C. has declined to consider the candidature of the present applicant from the category of Orphan. The learned counsel submitted that insofar as the position based on the G.R. dated 2.4.2018 is concerned, the distinction was possible whether to consider the applicant in the category of Orphan entitled to the benefit as per the said G.R. The learned counsel submitted that, however, after issuance of G.R. dated 23.8.2021 the confusion has been removed and the persons alike the applicant are also made eligible for claiming reservation meant for Orphans. The learned counsel further submitted that, as mentioned in the said G.R. it would apply to all the examinations and recruitments after 2.4.2018. The

learned counsel pointed out that under the orders of the Hon'ble High Court the applicant was permitted to appear for mains examination, however, her result has not been declared so far. The learned counsel pointed out that the result of the mains examination has been declared on 27.3.2022 i.e. after 2.4.2018, and as such, the M.P.S.C. was bound to consider the candidature of the applicant from the category of Orphan. The learned counsel in the circumstances has prayed for allowing the Original Application and directing the M.P.S.C. to declare the result of the applicant and consider her case on merit for appointment on the subject post in order of merit.

4. The learned Presenting Officer sought to contend that at the relevant time the M.P.S.C. has rightly declined to consider the candidature of the applicant from the Orphan category on the basis of earlier Resolution. However, in view of the subsequent Resolution the learned Presenting Officer prayed for passing appropriate order in the matter.

5. We have considered the submissions advanced by the learned counsel appearing for the applicant and the learned Presenting Officer appearing for the respondent authorities.

6. It is the grievance of the applicant that the M.P.S.C. is not extending the benefit meant for the candidates falling

in the category of Orphan based on some earlier Government Resolutions and Circulars. The applicant has obtained the certificate of being Orphan from the competent authority and same is placed on record. As per G.R. dated 23.8.2021 the definition of Orphan is extended to the children, who have lost their parents but they were brought up and looked over by relatives and they are also included in the definition of Orphan. The aforesaid G.R. is made applicable for all the recruitment processes carried out after 2.4.2018 of which final results are not published. As has been pointed out by the learned counsel for the applicant the result of the main examination in the instant matter has been declared on 27.3.2022 i.e. after 2.4.2018, and as such, the benefit given for the candidates falling in the category of Orphan is liable to be extended to the present applicant. The factual aspects are not disputed by the learned Presenting Officer. According to us, the applicant who was not covered under category of Orphan as per earlier G.R. is now in possession of a valid Orphan certificate category (b), issued by competent authority under G.R. dated 23.8.2021, therefore, the request made by the applicant in the present application deserves to be allowed. In the circumstances, the following order is passed :-
