- 2. The Ld. Advocate for the Applicant states that the applicant married his wife in 2006. She was appointed as Nurse on 29.4.2008 at Solapur in the institute of Respondent No.1. On 26.4.2010 the wife of the Applicant committed suicide. The Applicant was charged under Section 306, 323 etc of IPC. He was acquitted of the offences on 6.10.2012.
- 3. The Ld. Advocate for the Applicant contends that the Applicant did not request for compassionate appointment upto 24.4.2013. The reasons furnished by him are not satisfactory and convincing. The impugned order issued on 9.10.2013 relies on GR dated 22.8.2005. It states that application should be made within one year from the death of the employee.
- 4. Ld. Advocate for the Applicant relies on the judgment dated 19.12.2011 of the Hon'ble Madras High Court in W.P. No.10490 of 2009. The facts mentioned therein are not relevant in the present case.
- 5. I have gone through the impugned orders at page 62-63 of OA. The order is clear and speaking. The delaymentioned has not been explained by the Applicant.
- 6. Hence, I see no reason to interfere in the same and the OA is therefore dismissed.
