Heard Shri S.L. Bhapkar, learned counsel for the applicants in all these O.As. and S/shri M.S. Mahajan, B.S. Deokar & M.P. Gude, learned Chief Presenting Officer and Presenting Officers for the respective respondent authorities in respective O.As. and Shri S.B. Mene, learned counsel for respondent No. 3 in O.A. No. 85/2023.

2. Since in all these matters the grievance raised and the prayers made are identical, we have heard all these matters together and deem it appropriate to decide all these matters by this common order.

3. The applicants are retired State Government employees. Admittedly, all of them had entered into

the Government service after 01.11.2005. Obviously therefore, the old pension scheme was not applicable to them. It is however, the contention of the applicants that after retirement, the applicants were certainly entitled for the amount of gratuity. Since it was not paid even after making representations, the applicants have approached this Tribunal.

4. During pendency of the present Original Application, the State Government vide its G.R. dated 31.03.2023 resolved to pay the gratuity to the employees, who entered into the Government service after 01.11.2005, on their retirement. Since there was some ambiguity whether the said G.R. would be applicable for the Government employees retiring thereafter or would also be applicable for the Government servants already retired in the period between 02.11.2005 and the date of the said G.R., another G.R. dated 24.08.2023 came to be issued wherein it has been clarified that the State Government employees, who have already retired and who will retire thereafter would be entitled for the amount of gratuity.

5. After having perused the aforesaid 2 G.Rs. dated 31.03.2023 and 24.08.2023, the applicants apparently appear eligible to the benefit of the said G.Rs. In the present Original Applications, the same prayer has been made i.e. entitlement for the amount of gratuity. Now the State Government has taken a policy decision to pay the amount of gratuity even to the employees, who entered into the Government service after 01.11.2005 and to whom the old pension scheme is not applicable. After issuance of G.Rs. dated 31.03.2023 and 24.08.2023, there has remained no doubt that the benefit of G.R. dated 31.03.2023 would be extended even to the Government employees, who have retired before issuance of the said G.R. and who entered into the Government service after 01.11.2005.

6. In view of the subsequent developments occurred as above, it appears to us that the present Original Applications can be disposed of by directing the respondents to consider the cases of the present applicants for their entitlement to the payment of gratuity to them as provided under the aforesaid 2 G.Rs. and if the applicants are found eligible, to

remit the amount of gratuity in favour of each of them within a period of 3 months from the date of this order.

7. As procedural aspect, if the applicants are required to submit a fresh representation based on G.Rs. dated 31.03.2023 and 24.08.2023, the applicants shall submit the same with the appropriate authority and the authority concerned shall process the application expeditiously and release the amount of gratuity in favour of each of the applicants as expeditiously as possible preferably within a period of 3 months from the date of this order.

8. The Original Applications stand disposed of with the aforesaid terms without any order as to costs.

Heard Shri A.B.Chalak, learned Counsel for the applicants/Interveners in M.A.St.No.1274/2022, Shri Vinod Joshi & Shri Shailendra Kulkarni, learned Counsel for the applicant in M.A.No.35/2019 in O.A.St.No.47/2019 and Shri M.S.Mahajan, learned Chief Presenting Officer for the respondent authorities.

2. Present M.A.St.No.1274/2022 has been filed by two persons seeking their impleadment as party respondents in O.A.St.47/2019. O.A.St.47/2019 has been filed by one Shri Balraj Shivraj Lanjile being aggrieved by the decision of the respondents to restart the open enquiry into assets of the applicant which was earlier decided to be closed. It is the contention of the applicants in the present M.A. that on their complaint, the Government has taken a decision to reopen the enquiry into the

assets of the original applicant. It is, therefore, contention of the applicants/interveners that they have locus to seek intervention in the O.A. filed by Shri Balraj Lanjile to oppose the request made by him (Shri Lanjile) in his O.A.

3. Shri A.B.Chalak, learned Counsel submitted that having regard to the fact that the open enquiry into the assets of the original applicant has been reopened on complaint of the present applicants, in fact, the applicant must have made them respondents; however, since the applicant has not made them respondents, the applicants/interveners have approached this Tribunal to allow them to intervene in the matter in the interest of justice. Learned Counsel further submitted that in absence of these applicants before the Tribunal in the O.A. filed by the original applicant, dispute as has been raised in the said O.A. would not be effectively adjudicated. Learned Counsel in the circumstances prayed for allowing M.A.St.No.1274/2022 for intervention.

4. Shri Vinod Joshi, learned Counsel appearing for the applicant opposed the submissions made on

behalf of the applicants in the M.A. Relying on the judgment of the Hon'ble Apex Court in the case of **Dr. Duryodhan Sahu & Ors. V/s. Jitendra Kumar Mishra & Ors. [(1998) 7 SCC 273]**, learned Counsel argued that the O.A. filed by the original applicant being a service matter, applicants cannot be in any way said to be aggrieved persons and hence cannot be permitted to intervene in the matter. Learned Counsel further submitted that it may be a fact that on complaint of the applicants the open enquiry pertaining assets of the applicant has been reopened, present is not the forum for applicants to agitate the said issue.

5. Learned CPO has submitted to pass appropriate order.

6. We have duly considered the submissions made on behalf of the learned Counsel appearing for the parties and learned CPO appearing for the State authorities. As has been submitted by Shri A.B.Chalak, learned Counsel appearing for the applicants/interveners since the open enquiry into the assets of the applicant in the O.A. has been reopened on the complaint of the applicants

(interveners), they have locus to seek their impleadment as respondents in the O.A. to oppose the contentions raised in the O.A. and the prayers made therein.

7. The prayer so made has been opposed by Shri Vinod Joshi, learned Counsel appearing for the applicant in the O.A. by relying on the law laid down by the Hon'ble Apex Court in the case of Dr. Duryodhan Sahu, *cited supra*. In the said case before the Hon'ble Apex Court appointment of the petitioner on the post of Junior Teacher (Lecturer) in Surgical Gastroenterology in Medical College was objected to by the General Secretary of Cuttack Surakhya Committee before the Central Administrative Tribunal (CAT) at Bhubaneswar. Another application was also filed objecting to the said appointments. Learned Tribunal partly allowed the application against which the petition was preferred before the Hon'ble Supreme Court. Hon'ble Supreme Court set aside the order passed by the learned Bench of the CAT at Bhubaneswar.

8. We have carefully gone through the observations made and the conclusions recorded by

the Hon'ble Supreme Court in the aforesaid matter. The facts involved in the present case are quite identical with the facts which existed in the matter before the Hon'ble Supreme Court. In the matter before the Hon'ble Supreme Court the appointment of the said petitioner was objected to by the General Secretary of Cuttack Surakhya Committee as well as two others on the ground that the petitioner did not possess the qualification prescribed for the post of Lecturer and further that the Government in order to accommodate him created another post which was not advertised. It was alleged that the petitioner had exerted influence over the authorities concerned and managed to secure appointment. It was further alleged that the appointment was not only *mala fide* and illegal but it was also against the public interest. Though the application was opposed by the Government, the Tribunal held that the application was maintainable at the instance of the applicants. The Tribunal observed that the most important question to be decided was whether Dr. Sahu possesses the requisite qualification and eligibility for the post of Junior Teacher (Lecturer) in Surgical Gastroenterology. The Tribunal

considering the said aspect restrained the appointment of Dr. Sahu as Lecturer. The aforesaid order was challenged by Dr. Sahu before the Hon'ble Apex Court. The Hon'ble Apex Court while allowing the petition filed by Dr. Sahu and thereby setting aside the order passed by the Central Administrative Tribunal held as under:

“18. The constitution of Administrative Tribunals was necessitated because of the large pendency of cases relating to service matters in various courts in the country. It was expected that the setting up of Administrative Tribunals to deal exclusively in service matters would go a long way in not only reducing the burden of the courts but also provide to the persons covered by the Tribunals speedy relief in respect of their grievances. The basic idea as evident from the various provisions of the Act is that the Tribunal should quickly redress the grievances in relation to service matters. The definition of "service matters" found in Section 3(q) shows that in relation to a person, the expression means all service matters relating to the conditions of his service. The significance of the word "his" cannot be ignored. Section 3(b) defines the word "application" as an application made under

Section 19. The latter section refers to "person aggrieved". In order to bring a matter before the Tribunal, an application has to be made and the same can be made only by a person aggrieved by any order pertaining to any matter within the jurisdiction of the Tribunal. We have already seen that the word "order" has been defined in the explanation to sub-section (1) of Section 19 so that all matters referred to in Section 3(q) as service matters could be brought before the Tribunal. If in that context Sections 14 and 15 are read, there is no doubt that a total stranger to the service concerned cannot make an application before the Tribunal. If public interest litigations at the instance of strangers are allowed to be entertained by the Tribunal, the very object of speedy disposal of service matters would get defeated."

9. The facts involved in the present M.A. are quite identical with the facts which existed in the aforesaid matter before the Hon'ble Apex Court. In the present matter, though it may be a fact that the enquiry into the disproportionate assets of the applicant has been reopened on complaints of the applicants in the present M.A., in view of the law laid down by the Hon'ble Apex Court in the case of Dr. Duryodhan Sahu (*cited supra*), they cannot be held to be "persons aggrieved" in order to bring their

application within the jurisdiction of this Tribunal.
For the reasons stated above following order is
passed:

ORDER

M.A.ST.NO.1274/2022 is rejected without any
order as to costs.
