- 5. This matter was partly heard on yesterday and directions were given to learned P.O. to take instructions from the Respondents as to what is the present status of D.E. in respect of the complaint dated 04.02.2021.
- 6. Today, learned P.O. submits that complaint dated 04.02.2021 has been forwarded to Joint District Registrar, Pune on 13.09.2022. Thus, according to him, the Respondent did not take any further action in respect of said complaint and awaiting for the reply from Joint District Registrar, Pune.
- 7. Notably, the perusal of letter dated 13.09.2022 addressed to Joint District Registrar, Pune reveals that Respondent had sent the said complaint to him for further appropriate action at his level.
- 8. Thus, apparently no such disciplinary proceeding or criminal prosecution is initiated against the Applicant till date.

 - 12. In the meantime, the Respondent is at liberty to initiate D.E. in accordance to law and if any such decision is taken and D.E. is initiated, it be also finalized within two months from the date of initiation of D.E.
