- 2. Learned PO present copy of letter dated 24.04.2024 of 'Joint Commissioner, State Excise (Admin)' in office 'Commissioner State Excise, Maharashtra State, Mumbai'; wherein it has been mentioned that request of Applicant could not be considered as representation was made belatedly by Applicant on 31.01.2024 and it was received on 01.02.2024 after posts of 'Sub Inspectors, State Excise' had been filled up by Transfer Order dated 29.01.2024.
- 3. Learned PO further emphasized that although request of Applicant was belatedly received on 01.02.2024 in office of 'Commissioner State Excise, Maharashtra State, Mumbai'; but Applicant had requested for 10 posts of 'Sub Inspector State Excise' which are all categorized as 'Executive Posts'. Hence, Applicant could not be again transferred to 'Executive Post' as per directions in Home Department (State Excise) Government Letter dated 25.05.2021 addressed to 'Commissioner State Excise, Maharashtra State, Mumbai'.
- 4. The Home Department (State Excise) Government letter dated 25.05.2021 does not mention 'Source of Law' or relevant 'Rules & Regulation' on the basis of which such classification has been made between 'Executive Post' and 'Non-Executive Posts' of 'Sub Inspector State Excise' by the 'Commissioner State Excise, Maharashtra State, Mumbai'.
- 5. The 'Commissioner State Excise, Maharashtra State, Mumbai' has relied only on Home Department (State Excise) Government Letter dated 25.5.2021 to arrive at conclusion to reject the request of Applicant made on 31.01.2024. The Home Department (State Excise) Government Letter dated 25.05.2021 cannot even be considered to be 'Policy Decision' taken by issuing 'Government Resolution' or 'Government Circular'.

Tribunal's orders

Further such sub-classification of posts made by 'Administrative Departments' does not have any force of law as no such mention is made in either 'Section 2(g)' or 'Section 3(1)' of 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005'.

- 6. The 'Commissioner State Excise, Maharashtra State, Mumbai' was thus expected to tread cautiously while deciding matters relating to exercise of 'Statutory Powers' under 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' which clearly do not embody any sub-classification of posts of 'Government Servants' into 'Executive Post' and 'Non-Executive Posts'. Question therefore arises as what has not been provided by law, rules and regulations or even brought in as 'Policy Decision' through 'Government Resolution' 'Government Circular', cannot be sought to be effected by way of ordinary communication as has been done through Home Department (State Excise) letter dated 25.05.2021. Necessary also for 'Commissioner Maharashtra State, Mumbai' is to examine whether such classification of posts would be desirable to do under 'Special Legislation' Viz 'Maharashtra Prohibition Act 1949'.
- 7. The 'Commissioner State Excise, Maharashtra State, Mumbai' by rejecting the request of Applicant in cavalier manner has also undermined the policy decision taken by GAD GR dated 21.11.2022 granting preference to 'Ex-Servicemen' in matters of transfer subject to policy guidelines GAD GR dated 09.04.2024.
- 8. The 'Principal Secretary Home (State Excise)' is hence informed to take note of the observations made above and examine validity of instructions given to 'Commissioner State Excise, Maharashtra State, Mumbai' by way of Home Department (State Excise) Government Letter dated 25.05.2021 and if such classification of posts of 'Sub Inspector State Excise' as 'Executive Posts' and 'Non-Executive Posts' could be justifiably used for rejection of request of 'Applicant' who is an 'Exserviceman'.

Hence considering the policy guidelines in GAD GR dated 09.04.2018 in all fairness

Tribunal's orders

'Applicant' and 'Husband' cannot be restricted to seek transfers only in jurisdiction of 'S.D.O Gadhinglaj, District Kolhapur'. So; they are given liberty to submit fresh joint representation to 'District Collector, Kolhapur' to seek transfers under jurisdiction any of the 'Sub Divisional Offices' in Kolhapur District.

- 6. The 'District Collector, Kolhapur' as per extant policy guidelines in GAD GR dated 09.04.2018 to consider the fresh joint representation of 'Applicant' and 'Husband' and thereupon take appropriate decision during 'General Transfer: 2024' keeping in mind the cited 'Personal Hardships'.
- 7. The O.A. No. 708/2023 is accordingly disposed off. No Order as to Cost.
