- 2. The learned Counsel for Applicant submits that the Applicant appeared in the Maharashtra Subordinate Services, Group B Examination 2022 conducted by MPSC for post of 'Police Sub Inspector' as per Advertisement No.036/2023, dated 14.08.2023.
- 3. The learned Counsel for Applicant stated that Applicant qualified for all the stages of examination but in 'Physical Examination', wrong marks were given to Applicant because of the same, he scored 1 mark less of the Qualifying Mark required for 'Physical Examination' which is 60 out of 100.
- 4. The issue raised by Applicant pertains to how much marks are given and the method for giving marks for 'Physical Event' of Pull-Up to the candidates who participated in the Physical Examination. The said Physical Event is at Serial No.2 of letter dated 16.05.2024 allocating the marks on the basis of performance by candidates for which 20 marks are allocated for 8 pull-up i.e 20 marks for successfully doing 8 Pull-Ups. As per marks allocation shown for 'Physical Event' of Pull Up in the Physical Examination letter dated 16.05.2024, a full 2.5 marks will be awarded, if a candidates compete Pull-Ups without struggling and/or within sweeping

or bending their legs, and importantly Pull-Ups will be deemed to have been completed by candidates after they Touch Chest to the Horizontal Bar. If candidate is not able to pull-up i.e. he is not able to Touch Chest to the Horizontal Bar, then he will not get any marks for that particular Pull-Up. However, if at all the candidate has completed Pull-Up after they easily reached the Horizontal Bar to Touch Chest but if he bends his leg while performing Pull Up then he will be awarded any marks between 1 and 2.5 marks as per contents of 'Para 2' of Annexure-A for Malse Candidates of MPSC Letter dated 16.05.3034 addressed to Applicant for Physical Examination.

- Applicant has completed 4 Pull-Ups so he is entitled to get 10 marks for 4 Pull-Ups . However, Applicant has been given 7.5 marks. Learned Counsel submits that assuming if in 1 Pull-Up, the Applicant bend his legs and made wrong movement of legs then only 1 mark should have been deducted from 2.5. He submits that Applicant in all 4 Pull-Ups had been successful and did Touch Chest to Horizontal Bar. In fact, learned Counsel submits that Applicant is entitled to get 9 marks and if at all he secured 1 mark more, he becomes eligible for Interview. He submits that Interviews for the post of 'Police Sub-Inspector' are going to commence from today itself.
- 6. We have seen the CCTV Footage produced before us on Laptop by learned Counsel for Applicant. It appears that out of 4 Pull-Ups, the Applicant has successfully completed 3rd Pull-Up but in the 4th Pull-Up, he could not Touch Chest to Horizontal Bar for which 'No Marks' are to be awarded to candidates. Therefore, we do not find there is any ground to take indulgence in the case of Applicant and no interference is required to be made on the decision taken by the Committee of Experts.
- 7. The Original Application No.766/2024 is thus dismissed. No Order as to Costs.

- 3. Issue notice before admission returnable on 29.07.2024.
