- 4. In view of above, the Applicants have prayed for directions to repatriate them to Thane District.
- out that in similar situation, this Tribunal has already passed orders of repatriation from Thane District to Palghar District and those orders were maintained by the Hon'ble High Court. In so far as recalling the order of imposition of cost of

Rs.10,000/- is concerned, learned C.P.O. submits that the Respondents did not get opportunity to file the reply in the

O.A., and therefore, the order of cost be recalled.

Tribunal's orders

- 6. The Tribunal has imposed the cost of Rs.10,000/- having regard to the fact that the Applicant stands retired on 31.07,2015 and deprived of retiral benefits for considerable time. departmental enquiry initiated against him during service, was concluded by the inquiry officer in 2014 exonerating the Applicant. However, the Respondents did not take any action for more than four years and it is only in 2018 the show gause notice was issued as to why 10% pension should not be deducted permanently. As such, having noticed inaction and lethargy on the part of the Respondents to pass final order in D.E., the cost of Rs.10,000/- to compensate the Applicant. Suffice to say, the Tribunal has recorded sufficient reasons while imposing the cost. I am, therefore, not inclined to recall the order of imposition of cost.
- 7. In view of above, Misc. Application is dismissed with no order as to costs.
