2. Though by order dated 07.03.2024, the present Original Application is allowed for the reasons to follow, however while perusal of the file and annexures for recording the reasons, it appears that by order dated 16.12.2007; the applicant was inflicted with the punishment of dismissal from service in terms of the conclusions drawn in the Departmental Enquiry. Being aggrieved by the same, the applicant has preferred appeal/re-appeal before the appellate authorities. However, the said appeal/re-appeal came to be dismissed. Thereafter, the applicant has filed Revision Application before the Hon'ble State Minister Home. By order dated 10.12.2015, the then Hon'ble State Minister Home has set aside the dismissal order and instead directed stoppage of annual increments for a period of three years. In terms of the said order, the applicant came to be reinstated in service on 18.12.2015.

However, the applicant remained not on duty including the period of suspension preceding of his dismissal. It further appears that by order dated 10.04.2017, the Government has regularized the said period for the purpose of his pensionary benefits, however granted 50% of full pay and allowances during the said absence period, which is almost eight years and some odd months. However, the said order is not placed on record by the applicant. It further appears that after retirement when the Pay Verification Unit has raised an objection about it, the revised pay fixation was done in terms of the aforesaid order, but till then the pensionary benefits were paid to the applicant. It appears that the recovery thus proposed and accordingly, the amount has been recovered for the said excess payment. It appears that the applicant has not specifically brought the factual aspect on record.

3. In view of above, it is necessary to list the present matter for rehearing on 08.04.2024.

# ORIGINAL APPLICATION ST. NO.729/2024 (Santosh Balasaheb Todekar Vs. State of Maharashtra & Ors.)

Heard Shri M.S.Choudhari, learned Counsel for the applicant and Shri V.G.Pingle, learned Presenting Officer for the respondent authorities.

- 2. Grievance of the present applicant is that he has not been given an opportunity to submit EWS Certificate on record. As is revealing from the documents the applicant though applied from EWS category did not submit the appropriate EWS Certificate as provided under G.R. dated 31-05-2021 and that is the reason that he has not been considered. Learned Counsel for the applicant submitted that when the applicant was allowed to appear for the examination and objection was not raised, now respondents cannot deny opportunity to the applicant on the ground that he did not submit EWS Certificate on record.
- 3. The contention so raised is liable to be rejected at the threshold. Entire compliance is seen at the

time of documents verification. In the advertisement, there is a specific clause which put the candidates under obligation to comply with all the conditions prescribed in the advertisement. One of the conditions is that candidates seeking benefit of EWS must be possessing requisite certificate in the appropriate format on the date of filing the application and must produce the same on the date of scrutiny of documents.

4. As provided in the G.R. dated 12-02-2019, the candidates who desire to avail the benefit of EWS category are under an obligation to possess Non-Creamy Layer Certificate evidencing that total income of family of the said candidate for the accounting year preceding the year in which the advertisement is published, was not more than 8,00,000/- (Rs. Eight lacs only). In the present matter, advertisement was published on 08-06-2023. The candidates were, therefore, under an obligation to possess and accordingly place on record for verification the certificate evidencing that income of family of the said candidate for the year 2022-23 was not more than Rs.8,00,000/-.

- 5. The applicant has placed on record certificate issued on 17-11-2022 which is pertaining to the vear 2021-22. It is thus evident that the said certificate was not in compliance with the conditions as incorporated in the advertisement as well as in the G.R. dated 12-02-2019. Another certificate which has been filed on record by the applicant is dated 30-01-2024. No doubt, the said certificate is certifying income of family of the candidate for the accounting year 2022-23 as less than Rs.8,00,000/-. However, admittedly, the said certificate was not possessed by the applicant on the last date of submitting the application in pursuance of the advertisement dated 08-06-2023 nor was produced on record by the applicant at the time of scrutiny of the documents.
- 6. Having considered the facts as aforesaid, it does not appear to us that any error has been committed by the respondents in not including the name of the applicant in the list of selected candidates from EWS category. In the aforesaid circumstances, it does not appear to us that any case is made out by the applicant even for issuing

notice to the respondents in the present matter. Therefore, the O.A. deserves to be dismissed summarily. Accordingly, it stands dismissed. No costs.
