- (C) Pending hearing and final disposal of Original Application, the Hon'ble Tribunal be pleased to direct the respondent to give effect and deemed date promotion to the applicant for the post of Maharashtra Agriculture e

Service Group- A, on the basis of the seniority list dated 1.1.2022.

- (D) Pending hearing and final disposal of Original Application, respondents are not issue any promotional order on post of Maharashtra Agriculture Service Group-A, on the basis of the seniority list dated 1.1.2022 to the other equivalent as well as junior employees as per the list dated 28.2.2023;
- (E) Pending hearing and final disposal of Original Application, one post be vacant in Nashik Division on post of Maharashtra Agriculture Service Group- A, as per the list/G.R. dated 28.2.2023 and please to the name of applicant in the list/G.R. dated 28.2.2023;
- (F) Ad-interim relief it term of prayer clause (A) to (E)."
- 4. It is noticed that the applicant has made representation to the respondent Nos. 1 and 2 on 02.03.2023 through post/email and hurriedly filed the present O.A. on 08.03.2023, which is not a good practice.
- 5. As the applicant has specifically prayed for keeping one post vacant for the applicant in Nashik Division, if has been clarified to the applicant that the present O.A. cannot influence allocation of Revenue Division at this stage in anticipation that the applicant is going to succeed. Moreover, in case, the Tribunal arrives at conclusion that the process of granting promotion as adopted by the respondent authorities, suffers from any fatal infinity then the remedy will be available to all as per correct procedure including correct seniority cum merit position of all the candidates. No seat can be reserved for any applicant excluding any more meritorious candidate, who is found to be eligible for priority promotion.

- 6. After considering all the facts in the matter, I am of the considered opinion that the respondent authorities may go ahead while promotion to the post of Maharashtra Agriculture Service, Group-A as per rules which will be subject to outcome of this O.A.
- 7. Interim relief prayed for in terms of keeping one post vacant over and above two posts already kept vacant, which gives wrong impression of the vacant post being kept reserved for the respective applicant, to absolute exclusion of any more meritorious candidate falling in the zone of consideration. Therefore, in my opinion, there is no merit in keeping one post vacant against each original applicant.
- 8. Therefore, interim relief in following term only is being granted:-

"The promotion order issued by respondents shall be subject to outcome of the present Original Application."

- 9. Time is granted as a last chance to the respondents to file affidavit in reply, failing which the matter may be finally heard without the same.

- 2. It is the case of the applicant no. 1 that his deceased father namely Vyankat Sopanrao Agashe was in the employment of Forest Department as Vanmajoor and since he worked in the period between 1.11.1989 to 31.10.1994 for 240 days in every year was entitled to be absorbed in the Government service and was also entitled for the benefit arising out of his absorption. Vyankat Agashe died in the year 2011 and till that period though he was also making efforts for his regularization, as well as, release of the arrears of his wages, the same could not be paid. Thereafter the present applicants i.e. son and wife of the deceased have prosecuted the matter further.
- 3. The learned counsel for the applicants pointed out that the respondents have principally agreed entitlement of the applicant and accordingly a proposal was also

forwarded. The learned counsel submitted that in the forwarded consolidated proposal already bv the respondents the name of the deceased Vyankat Agashe was there, however, against his name amount was remained to be mentioned and therefore, the deceased Vyankat Agashe could not get the said amount. learned counsel pointed out that on 15.3.2007 the Additional Chief Conservator of Forest, Nagpur has forwarded the proposal to the State Government i.e. to the Principal Secretary (Forest), Revenue & Forest Department and the same has not yet been considered by the respondents. The learned counsel, in the circumstances, prayed for direction to the respondents to decide the said proposal within the time bound manner and accordingly if the deceased is found entitled to remit the benefit also in the time bound manner.

4. The learned Presenting Officer reiterated the contentions raised in the affidavit in reply. In the reply it is contended that the policy decision was taken in the year 2012 and since the deceased Vyankat Agashe i.e. father/husband of the present applicants was not alive in the said year, there was no question to give benefit of 2012 Government Resolution to the applicants.

5. The say as has been submitted on behalf of the respondents is apparently incorrect since prior to 2012 decisions were taken for absorption of the Vanmajoors. Since the respondents were prima-facie convinced with the documents with them, the name of the deceased Vyankat Agashe was included in the list of eligible candidates and the arrears were also specified. That was the reason that the proposal was forwarded on 15.3.2007. The said proposal has yet not been decided. The applicants have filed the present O.A. with that limited prayer. The same deserves to be allowed. Hence the following order:-

#### ORDER

- (i) Respondent no. 5 shall decide the proposal dated 15.3.2007 on its own merit within the period of 3 months from this order and communicate the decision to the applicants and if deceased Vyankat Agashe is found eligible, release the monetary benefits payable to deceased Vyankat Agashe in favour of the applicants within 2 months thereafter.
- (ii) The Original Application stands disposed of in the aforesaid terms. No order as to costs.
