“B) *The respondent authorities may kindly be directed to issue No Objection Certificate for release all Pensionary benefit like regular pension and gratuity with 9% interest per annum within 30 days from the date of order.*

C) *The respondent authorities may kindly be directed to pay the salary of additional charge held by the applicant of the financial year 2009 to 2012 & remaining all arrears of applicant with 9% interest per annum & directed to pay the Rs. 20,000/- Advocate fees to the applicant within 30 days from the date of order.”*

3. Learned Advocate for the applicant has submitted that the cause of action to the applicant arose after his retirement and the applicant is residing at Aurangabad after his retirement. Therefore, the present Original Application is maintainable before this Bench in view of the provisions of Rule 6 of the

Maharashtra Administrative Tribunal (Procedure) Rules, 1988.

4. Learned Presenting Officer has submitted that the applicant retired from the office of Electric Inspector, Akola. He has submitted that the applicant was posted at Akola at the time of his retirement and therefore, the cause of action to the applicant has arisen at Akola and therefore, the present O.A. is not maintainable before this Bench of the Tribunal in view of the provisions of Rule 6 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988.

5. I have gone through the provisions of Rule 6 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, which provides as follows:-

**“6. Place of filing applications.-**  
*The application shall ordinarily be filed by the applicant with the Registrar of the Bench within whose jurisdiction,-*

- (i) the applicant is posted for the time being, or*
- (ii) the cause of action has arisen, or*
- (iii) the respondent or any of the respondents against whom relief is sought, ordinarily resides :”*

6. In the instant case, the applicant retired from the post of Electrical Inspector from the office of Electrical Inspector, Akola on 30.04.2013. After retirement, the cause of action for claiming pension arisen to the applicant at Akola. In view of the provisions of Rule

6(i) and 6(ii) of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, the applicant has to file the O.A. before the Bench under whose territorial jurisdiction cause of action has arisen. In the instant case the applicant retired from the office of Electrical Inspector, Akola and Akola does not come within the territorial jurisdiction of this Bench. Moreover, on perusal of the application, it reveals that all six respondents are residing at Mumbai. Therefore, in my view, the present O.A. is not maintainable in view of the provisions of Rule 6 (i) to (iii) of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988. This Bench of the Tribunal has no jurisdiction to entertain the O.A and therefore, the same is not maintainable.

7. In view of this, the Original Application along with the documents filed along with it be returned to the applicant. The applicant shall collect the O.A. from the Registry of this Bench within 15 days from the date of this order and to present the same before the appropriate Bench of the Tribunal.

2. Learned Advocate for the Applicant has submitted that the Applicant has been absorbed by G.R. dated 16.09.2019 on the post of Dental Surgeon, Group 'B' in the pay scale of Rs.9300-34,800 with grade pay of Rs.5400.

3. Learned Advocate for the Applicant has submitted that the Applicant is getting more pay than the pay scale granted in the G.R. dated 16.09.2019 and therefore, he has prayed to protect the pay of the Applicant.

4. Learned P.O. for the Respondents has submitted that the Applicant has been absorbed by G.R. dated 16.09.2019 subject to condition mentioned in the clause No.2 of the G.R. She has submitted that her earlier pay was not protected by the said G.R. and therefore, the Applicant cannot pray to protect the pay.



The Applicant was initially appointed on ad-hoc basis and therefore the same cannot be protected.

5. On perusal of the record it reveals that the Applicant was initially appointed on ad-hoc basis. She has been absorbed by G.R. dated 16.09.2019 on certain condition in the pay scale of Rs. 9300-34,800 with grade pay of Rs.5400. Her pay has not protected under the said G.R. In the circumstances, in my view, the interim relief regarding pay protection cannot be granted at this juncture as the issue requires to be decided on merit on full fledged hearing in the matter. Hence, the request to grant interim relief is hereby rejected.

6. Issue notices to the respondents, returnable on 17.01.2020.

7. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

8. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
