	her entitlement immediately. The Tribunal has also noted

4. True, during the period of service of near about 17 years, the Applicant has working at different places. She was earlier posted at St. George Hospital, Mumbai then transferred to Kama & Albless Hospital, Mumbai and presently working as Medical Superintendent on the establishment of Respondent No.3 (Civil Surgeon, Civil Hospital, Thane). However, working on different establishments can't be the ground for not updating the service book and for not releasing yearly increments to which the employee is entitled as of right unless withhold by the Competent Authority.

5. It is on the above background having found that the response of the Respondents is far from satisfaction, this Tribunal has passed the order on 17.06.2019 directing the Respondent No.1 to file Affidavit explaining the delay for not granting service benefits to the Applicant as well as to explain the steps taken by the department in terms of order passed by this Tribunal earlier on 03.05.2019. It was further directed that Affidavit be filed within a week without fail.

6. Despite this specific directions, no Affidavit is filed though the period of more than two weeks is over and no reason is forthcoming for non compliance of the order.

7. None is present on behalf of the Respondent No.1. It was expected that some responsible officer should remain present to explain the lapses on the part of concerned authorities but the Respondent No.1 seems to have no regard to the orders passed by this Tribunal. It is very unfortunate that the Government servant is struggling for her legitimate dues for 17 years.

8. In view of above, issue show cause notice to Respondent No.1 as to why the action for contempt of court should not be initiated against him for non compliance of the order dated 17.06.2019. Reply be filed within a week.

9. Learned P.O. is directed to communicate the order to the Respondent No.1 immediately.

10. Hamdast and steno copy is granted.
