3. Now, the Applicant has again filed present O.A. raising grievance that despite direction given by the Tribunal in O.A.No.255 of 2019 final pension, gratuity and benefit of 6<sup>th</sup> and 7<sup>th</sup> Pay Commission is not granted.
4. Whereas learned P.O. for the Respondents submits that amount of GIS and GPF and arrears of 6<sup>th</sup> Pay Commission is already released. As regards pension he submits that file is under process. In respect of gratuity he submits that there is recovery of Rs.2,55,284/- towards penal rent and excess payment. As regards benefit of 7<sup>th</sup> Pay Commission, he submits that the Applicant was absent and therefore he is not entitled to the benefit of 7<sup>th</sup> Pay Commission in terms of Government Resolution dated 20.02.2019.
5. In view of the above, learned P.O. for the Respondents is directed to release regular pension as per entitlement of the Applicant within two weeks.
6. Steno copy and Hamdast is allowed.
7. Adjourned to 20.11.2019, for hearing at the stage of admission.






