Thus protection will come to an end today and therefore the applicant needs interim protection for further period till decision of this OA or till they file reply. Ld. Advocate for the applicant in support of his submission relies on his earlier application which he has made at the entry level where he has sought entry in open category and not in reserved category.
- 3. After hearing Ld. Advocate for the applicant and going through the record of the matter, we are of the view

that we need to go through some more documents which can be produced by the respondents especially service book of the applicant along with necessary record where the record of his entry in open category or in reserved category will be found. We keep the matter of interim relief open.

- 4. I.d. PO is directed to take necessary instructions whether the applicant has taken benefit of reservation or is considered in open category.
- 5. It is seen from record that services of applicant were terminated on 20.8.2001. The applicant was given fresh appointment subsequently in 2002. The application form enclosed by the applicant pertains to his prayer in the year 1998. The applicant needs to produce application form at the time of fresh appointment in 2002.
- 6. The office objections, if any, are to be removed and court-fees to be paid, if not already paid.
- 7. Issue notice before admission returnable on 8.4.2021.
- 8. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is allowed in view of this present COVID-19 Pandemic situation. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- 9. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- 10. The service may be done by hand delivery/ speed post/courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file affidavit of compliance and notice.
