1. Heard Ms Neha Bhide with Shri C.T Chandratre & Shri M.B Gawade, learned advocate for the applicant, Ms Swati Manchekar, learned C.P.O for Respondents 1 to 6 and 84, Shri M.D Lonkar,



learned counsel for Respondents no 7 to 10, 13, 15, 16, 27, 29 to 31, 40, 47, 52, 53 and 84-A, Shri G.B Solanke, learned counsel for Respondents no. 11, 14, 17, 32, 33, 36, 38, 41 & 42 and Shri S.J Pawar, learned counsel for Respondents no 18, 20, 35, 37, 43, 49 & 51. Learned counsel submits that he is filing affidavit in reply along with Vakalatnama and states that he will file affidavit in reply within two weeks.

- 2. In M.A 475/2019, learned counsel for the applicant wants to amend the Original Application by adding Mr Devidas Balkrishna Kulal, presently working as Education Officer, Group-A and posted as Joint Secretary, SSC & HSC Board, Kolhapur Division, as Party-Respondent no. 84-A and also add Paras No. 68(a), (b) and (c) & (d)
- 3. The proposed Respondent no. 84-A Shri D.B. Kulal has filed affidavit in reply dated 5.3.2020 opposing his addition to the array of the Party-Respondents. Mr Lonkar, learned counsel for the applicant-Respondent no. 84-A to argue on the point of adding Shri D.B Kulal, as Party Respondent no. 84-A on the next date. Mr Lonkar, learned counsel for the private Respondents submits that out of the group he is representing, he wants to file reply on behalf of three Respondents and he seeks one weeks' time.
- 4. Pursuant to order dated 13.1.2022, produced by the learned counsel for the applicant, the learned C.P.O informs that no post is available from the post which were advertised by Notification dated 21.10.2010. The chart which is produced along with letter dated 13.1.2022, which is acquired by the applicant under R.T.I, shows that there are 28 vacancies. However, these vacancies as on 13.1.2022 cannot be taken into account so far as the relief claimed by the applicant in respect of the advertisement for the post notified on 21.10.2020.

- 5. Learned counsel Mr C.T. Chandratre, for the applicant submits that today he is withdrawing M.A 476/2019, seeking condonation of delay in filing the Original Application.
- 6. M.A 476/20129 is allowed to be withdrawn and is accordingly disposed of.
- 7. Some of the Respondents are not represented and therefore, they have to take note to appear before the Tribunal latest by next date, otherwise the matter will proceed without their representation.
- 8. Two weeks' time is granted to all the private Respondents to file affidavit in reply. If no reply is filed within two weeks, the matter will proceed without their reply.

ORDER

- 1. Heard Shri B.A. Bandiwadekar, Ld. Advocate for the Applicant and Ms. S.P. Manchekar, Ld. Chief Presenting Officer for the Respondents.
- 2. Ld. Advocate for the applicant seeks leave to add General Administration Department as party respondent no.2.
- 3. Leave granted. Amendment be carried out forthwith and amended copy be served on all concerned.
- 4. The applicant is working as Assistant Chemical Analyzer in the office of Regional Forensic Science Laboratory, Ganeshkhind, Pune-7. The applicant, who is aspiring to appear for interview for the post of Assistant Director, Directorate of Forensic Science Laboratory, General State Service, Group-A, challenges the undated order of March, 2022 passed by Respondent No.1-MPSC declaring the applicant as not eligible candidate



for the interview, which is going to be conducted today i.e. 5.4.2022 and 6.4.2022. It is prayed that she is to be declared as eligible candidate and her name is to be included in the list of eligible candidates. Ld. Advocate for the applicant prays that she be allowed to appear for the interview, which is going to be conducted on 5th and 6th April, 2022, without prejudice to her claim in this matter.

- 5. The claim of the applicant is rejected on the ground that she has not fulfilled the criterion of experience of seven years in research. Para 4.4 of the advertisement dated 28.8.2018 reads as under:
 - "4.4 have acquired training and analytical or research experience in a recognized laboratory for a period of not less than seven years."
- 6. The applicant has filled up the form where she has given the details of her experience.
- 7. Ld. Advocate for the applicant submitted that the recruitment rules shall prevail over any circular or GR. If the recruitment rules i.e. para 4.4 of the advertisement, which is reproduced above, is read carefully, then the circular dated 3.7.2004 is found contrary. He relied on the experience certificate issued by the Head, Department of Chemistry, Savitribai Phule Pune University dated 28.8.2018 that the applicant has carried out 6 (six) years of Research and Analytical work of Ph.D. and she has completed her research paper i.e. Thesis. There are also peer reviewed research papers in her subject to her credit. Ld. Advocate for the applicant has further pointed out the experience certificate issued by the Principal, MES Abasaheb Garware College, Pune dated 14.9.2018 wherein the Principal has mentioned that the applicant has 3 (three) years 9 (nine) months of Research and Analytical experience at Department of Chemistry in the said college. She has completed Research Project funded by Board of



College and University Development. She has also published the Review articles and has guided six M.Sc. Projects. She has handled sophisticated analytical instruments viz. UV-Vis Spectrophotometer, Cyclic Voltammetry instrument from DST-FIST sponsored instrumentation laboratory. She has also worked on temporary basis for 10 (ten) months in the Department of Chemistry, Pune University as Teaching and operative duties.

- 8. Per contra, Ld. CPO pointed out that the circular dated 3.7.2004 is to be considered in order to decide which experience is to be counted as valid. As per the said circular the experience, 'on hour basis', 'periodical', 'part time', 'on stipend', 'visiting', 'contributory', 'without pay', 'incharge' and 'additional charge' is not a valid experience. Ld. CPO submits that applicant does not have requisite experience because in her application itself she has mentioned that she has worked periodically in MES's Abasaheb Garware College, Pune for three years and nine months. So that experience is not counted. Her experience in Savitribai Phule Pune University of six years and one month's is also not counted. Ld. CPO has submitted that the scrutiny of the application regarding experience is made by expert in the said field and the said list of eligible candidates is published. Ld. CPO therefore submitted that the ability of the expert cannot be questioned in the Court.
- 9. We have considered the submissions and also gone through all the certificates. In the rules the minimum educational qualification is considered a post graduate degree. Thereafter the applicant has completed 6 years research work in Ph.D. After securing Ph.D. she has worked at various places where she has received certificate of requisite experience. We fail to understand why expert has not considered the six years of Ph.D. work as research work and so also three years of her work at MES Abasaheb Garware College, Pune. Though she has mentioned as

Periodical it cannot be considered strictly as periodical unless meaning is explained by the respondent-department. Ld. Advocate for the applicant submits that applicant has written periodical as she was given the appointment for 11 months in these period of three years. In view of these facts and experience certificates which are produced by the applicant, prima facie, we are of the view that applicant be allowed to appear for the interview, however, her result is to be kept in sealed cover and results will be subject to the final outcome of this OA.

- 10. Ld. CPO submitted that expert is not accessible to anybody from MPSC but he is allowed to be contacted only by Deputy Secretary of MPSC or higher persons. Deputy Secretary is concerned person in this selection process. However, unfortunately there is a mishap in the house of Dy. Secretary and therefore he is not able to give instructions. GAD is directed to clarify what is meant by 'periodical' mentioned in the circular dated 3.7.2004, in view of the other criteria mentioned in the said circular of not valid experience. In view of the above, we pass the following order.
- 11. The MPSC is directed to call the applicant to appear for the interview on 6.4.2022. However, her result is to be kept in sealed cover. If the results are to be declared after the interview, MPSC to mention that, it is subject to the final outcome of the present OA.
