**ORDER**

1. Heard Dr. G. Sadavarte, the learned Advocate for the Applicants and Shri N.K. Rajpurohit, the learned Chief Presenting Officer for the Respondents.
2. This case was taken up in the morning at 11.05 a.m. and was adjourned for one hour. The case was again called out at 12.45 p.m. when nobody appeared for the Government. Thereafter order was dictated and accordingly interim relief was granted.
3. At 01.30 p.m., learned C.P.O. appeared with Shri Prashant Thakare, Tahsildar, Collector Office, Mumbai and stated that the orders passed on 13.06.2017 are being withdrawn / modified and fresh order will be issued today itself. Therefore, transcription of order was stayed.
4. In the afternoon session, learned C.P.O. has come up with fresh order dated 05.07.2017. It contained following version :-

“उपरोक्त मा. महाराष्ट्र प्रशासकीय न्यायाधिकरण, मुंबई यांचे अंतरिम निर्णयाच्या अधीन राहून व शासनाकडून पुढील आदेश प्राप्त होण्याच्या अटीच्या अधीन राहून खालील नमूद हंगामी कर्मचा-यांच्या हंगामी व तात्पुरत्या स्वरूपातील हंगामी सेवा पूर्ववत सुरु ठेवण्यात येत आहेत.”

It also contained further statement as follows :-

“उपरोक्त लिपिक/प्रगणक हे उपजिल्हाधिकारी व उपजिल्हा निवडणूक अधिकारी, जिल्हाधिकारी कार्यालय, मुंबई शहर यांचे प्रशासकीय नियंत्रणाखाली शासनाचे पुढील आदेश होईपर्यंत कामकाज पाहतील. तसेच वरील कर्मचा-यांना कायमस्वरूपी शासकीय कर्मचा-यांप्रमाणे सेवा विषयक फायदे मिळणार नाहीत.”

5. Learned Advocate for the Applicants has objection to the 2<sup>nd</sup> portion quoted hereinbefore, on the ground that it would contradict the interim relief of continuation of service of the Applicants.

6. Learned C.P.O. for the Respondents has taken instructions from Shri Prashant Thakare, Tahsildar, Collector Office and states that in the 2<sup>nd</sup> portion quoted in foregoing paragraph, does not refer to ‘tenure’ but it refers to the ‘office’ where the Applicants should continue to work at their present posting.

7. In view of the aforesaid, learned Advocate states that he is satisfied with the changed stance of the Respondents, and he states that M.A. may be accordingly disposed of as its purpose is accomplished.
