- Ld. PO states that parawise comments are received and seeks time to file reply of MPSC.
- Ld. PO is directed to take into account the ratio laid down in S.K. Makne (supra) while filing the reply. The OA is filed on 1.12.2023 however by way of amendment order dated 5.2.2024 & 6.5.2023 respondents no.4 & 5 are added. Respondents No.4 & 5 are directed to take into account the judgment in S.K. Makne (supra) while filing the reply.
- S.O. to 26.7.2024 by way of last chance. Interim relief to continue till final decision in the OA.
