#### ORDER

- 1. Heard Ms. Punam Mahajan, learned Advocate for the Applicants and Ms. S.P. Manchekar, learned Chief Presenting Officer for the Respondents.
- 2. The matter is taken for hearing on interim relief.
- 3. The learned Counsel for the Applicant submits that as per Rule 6 of the Notification dated 27.02.2021 incorporating the Rules of recruitment and promotions of all cadres of Nurses she submitted that Rule 6 is about the eligibility for the appointment of Public Health Nurses. She pointed out that Rule 6(a)(ii) is relevant in respect of the

eligibility of the Staff Nurses who claim promotion to the post of Public Health Nurses. Rule 6 (a) (ii) reads as under:-

- (ii) a Basic Bachelor of Science (Nursing) degree or General Nursing and Midwifery Diploma from recognized institute along with Post Basic Diploma in Public Health Nursing (11 month) from recognized institute;
- 4. The learned Advocate for the Applicant further submits that the Post Basic Diploma in Public Health Nursing of 11 months is made compulsory along with BSc. Nursing and also alongwith Diploma in Nursing and Midwifery. She submits that the applicants who are working as Staff Nurses since 1995 have secured a degree of BSc. Nursing and as per the earlier history of the promotion to the post of Public Health Nurses the degree of BSc. Nursing or Diploma in Nursing and Midwifery was sufficient. She pointed out that the direct recruits to the post of Public Health Nurses as advertised in 2019 is silent about the criterion of Post Basic Diploma in Public Health of 11 months but only limits BSc. degree Nursing or Diploma in Nursing and Midwifery. She submits that now the posts which are going to be filled up by nomination will not be holding the diploma in Post Basic Nursing Diploma of 11 months. However, the applicants who are in the service since 1995 and have secured the degree in Nursing or Diploma in Midwifery and Nursing are required to hold compulsorily the Post Basic Diploma in Public Health of 11 months along with BSc. Degree or diploma in Nursing and midwifery. She submits that this injustice has caused to the applicants who are 109 in numbers and who have service



span from 1995 to 2020 are deprived of the promotions of Public Health Nurses only because promotions have not taken place earlier i.e. prior to recruitment since 2012 entire process of promotions was stalled.

- 5. The learned C.P.O. on instructions from Ms. Archana Walzade, Under Secretary submits that in the Rules of February, 2021 the eligibility standard of the Public Health Nurses is upgraded whereas it is found that the Post Basic Diploma in Public Health is necessary along with their basic educational qualification which may be diploma in Nursing and Midwifery or it may be the degree of BSc. in Nursing. The learned C.P.O. submits that these Rules cannot be challenged for upgrading the eligibility criterion of Public Health Nurses.
- 6. Prima facie, it appears that there is no issue regarding upgrading the standard of the educational qualification of the Public Health Nurses as mentioned in Rule 6 of the said Rules. However, as pointed out by the learned Counsel for the Applicant the direct recruits who are going to be selected and appointed pursuant to the advertisement of 2019 will not be possessing the requisite qualification as per the present Rule 6. On perusal of the Advertisement of 2019 I find substance in the submission of learned Counsel for the Applicant pertaining to Rule 6 for eligibility of Public Health Nurses and Rule 4 for eligibility of Tutors which are contrary to the Rules. As the less qualified Nurses are going to be appointed to the posts by virtue of the advertisement which are contrary to the Rules, thus for promotions as per the Rules different criterion of upgraded educational qualification i.e. the Post Basic

Diploma in Public Health Nursing of 11 months is made applicable while for direct recruits for the same post, such qualification is not required. This appears contrary to Article 14 of the Constitution of India. Therefore the earlier order of interim relief that no further steps are to be taken in the appointment of the Direct Recruits pursuant to the advertisement of 2019 continues till further orders.

#### ORDER

- Heard Mr. Bhushan A. Bandiwadekar, learned Advocate for the 1. Applicant and Ms. Archana B.K., learned Presenting Officer for the Respondents
- The Applicant, Administrative Officer, Civil Hospital, Nashik 2. challenges the order dated 29.07.2021 passed by the Respondent No.1, the Director, Health Services Directorate transferring him from the post of Administrative officer, Civil Hospital Nashik to the office of Respondent No.1.
- 3. The learned Counsel challenges the order on following grounds:-
  - (a) Order is not issued by the competent authority. The Applicant is a Class-II, Group-B officer and therefore appointing authority is Respondent No.2, through Additional Chief Secretary, Public Health Department whereas the order is issued by the Respondent No.1, Director, Health Services Directorate.



- (b) Cadre strength is 159 out of which only 23 posts are filled-in. As per G.R. dated 09.07.2021 the State Government took a policy decision not to effect transfer in excess of 15% hence only 4 persons can be transferred. However, Government has transferred total 9 persons. By Government Resolution (G.R.) dated 29.07.2021 the maximum 25% of the available transfers can be made, thus 6% were transferable. He submits that further procedure of transfer followed in the case of the applicant is as per earlier G.R. 09.07.2021.
- (c) The applicant has given options. Copy whereof is at page 25 of O.A.. The options given are at various places at Nashik, Kalwan, Dhule, Jalgaon, Nandurbar, Ahmednagar, Malegaon, Yeola and Shirpur and no option of Mumbai was given at any time.
- (d) The Applicant further submits that his daughter is standing in 10 Std. in the academic year 2021-22.
- (e) The Applicant submits that in letter dated 28.07.2021 there were directions given to Respondent No.1 from the Government not to transfer officers from Group-B from the Public Health Department as the proposal of some officers is pending before the Government.
- (f) Another point is raised that the general transfers are to be made in April-May as per the Section 4(4) of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter referred as 'ROT Act, 2005' for brevity). As per Section 4(4) of ROT Act, 2005 transfers are to be made only once in a year in the month of April or May. He submits that if the transfer is to be made in any month than April or May, then sanction/ approval of the Hon'ble the Chief Minister is required. Applicant is transferred in the month of July without obtaining the approval of the Hon'ble the Chief Minister. The transfer is not made as per Section 4(4) and Section 4(5) of the ROT Act, 2005 and therefore it is mid-term transfer.

- (g) The meeting of the Civil Services Board (CSB) is to be conducted at the level of the Government.
- (h) The post of the Applicant is kept vacant and he is not yet relieved.
- 4. The learned P.O. replies on the above grounds:-
  - (a) By the G.R. of 09.07.2018 the power is delegated by the Director to the Joint Director.
  - (b) On instructions from Ms. Bhagwat, Administrative Officer, Public Health Department, learned P.O. submits that only 4 persons are transferred and not more, so that it fits into 15% as per G.R. dated 09.07.2021.
- 5. The learned Advocate pointed out recommendation letter dated 15.04.2021 sent by Dr. Ashok Thorat, Civil Surgeon, Nashik to Director Health Directorate, Mumbai along with the proforma giving the 10 preferences. Out of 10 preferences the Respondents have not considered any. Respondents are directed to answer why genuine reason, i.e. daughter of the applicant studying in 10 Std. in the academic year 2021 is not considered. Why the recommendation of the Civil Surgeon, Mr. Thorat as per his letter dated 15.04.2021 was not taken into account by the CSB. In view of the above, the impugned order dated 29.07.2021 is hereby stayed till next date.

- 1. Heard Shri A. V. Bandiwadekar, learned Counsel for the Applicant and Smt. Archana B. K., learned Presenting Officer for the Respondents.
- 2. Initially, the Applicant was dismissed from service by order dated 18.05.2010 and simultaneously by the same order recovery of Rs.33.7 lacks was ordered in terms of Circular dated 30.11.1978. The Applicant has challenged it by filing O.A. No.987/2010 and 260/2012 which was decided by common judgment dated 08.09.2015 and impugned order was quashed. However, the matter was remitted back to Disciplinary Authority for decision afresh.
- 3. In pursuance of it, the Government heard the matter afresh and modified the order of dismissal into order of compulsory retirement by order dated 13.05.2016. By the said order, recovery of Rs.33.7 lacks was also ordered to be made in terms of Circular dated 30.11.1978. This order is challenged by the Applicant by filing O.A.No.789/2017 which is subjudice before the Division Bench.
- 4. It appears later in view of the order of compulsory retirement, the compassionate monthly pension and gratuity was sanctioned. However, it was not paid further stating that the said amount (Rs.33.7 lacks) recoverable from the Applicant should be recovered from monthly pension payable to the Applicant as well as from him monthly salary which was payable to him before his retirement.
- 5. As such, the effect of order dated 05.03.2019 would be of withholding of entire monthly payable pension till the recovery of Rs.33.7 lacks.
- 6. Thus, in effect it is an order of withholding pension permanently till the recovery of Rs.33.7 lacks, perhaps, which could not be fully recovered during his life time.
- 7. The subject of permanent reduction in pension pertains to Division Bench. Therefore, this O.A. needs to be placed before the Division.
- 8. The Registrar is directed to act accordingly.
