The 'Government Order' dated 12.02.2024 of 'Revenue & Forest Department' came to be issued inspite of the fact that Applicant who was serving on post of 'Deputy Collector, Kal Project, Tahsil Mangaon, District Raigad' had not been entrusted with any specific responsibility such as of 'RO/ARO' or any work directly connected with conduct of 'General Elections Lok Sabha: 2024' from '32-Raigad Parliamentary Constituency'.
- The 'General Elections Lok Sabha 2024' are now over and as Applicant had been transferred only on grounds of having completed aggregated tenure of '3 Years' during last '4 Years' in 'District Raigad' but not the entitlement 'Normal Tenure' of '3 Years' on post of 'Deputy Collector, Kal Project, Tahsil Mangaon, District Raigad' as per provision of 'Section 3(1)' of 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' which is the determining criteria for transfers under law; hence 'Government Order dated 12.02.2024' of 'Revenue & Forest Department' in respect of Applicant cannot be held as valid as even 'Notification' if any under 'Section 28-A' of 'The Representation of Peoples Act, 1951' which may have included the post of 'Deputy Collector, Kal Project, Tahsil Mangaon, District Raigad' has

ceased to have the effect of 'Deemed Deputation' of Applicant to 'Election Commission of India.

- The transfer of Applicant though done under 'Section 4(4)(2)' & 'Section 4(5)' of 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' the criteria of aggregated tenure of '3 Years' during last '4 Years' in 'Revenue District' as included in directions of 'Election Commission of India letter dated 21.12.2023 is not 'intra-legem' under 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' which entitles 'Government Servants' of 'Normal Tenure' of '3 years' on any post subject to 'Mid-Term' & 'Mid-Tenure' which can be made in 'Exceptional Circumstances' or for 'Special Reasons' by recording of reason by 'Competent Transferring Authority' and with prior approval of next 'Superior Transferring Authority' under 'Section 4(4)(ii)' & 'Section 4(5)'.
- 6. The 'Government Order' dated 12.02.2024 of 'Revenue and Forest Department' it was pointed out also contravenes subsequent directions of 'Election Commission of India letter dated 23.02.2024' which subsequently restricted transfer of 'Government Servants' within same 'Parliamentary Constituency' which in case of Applicant is '32-Raigad, Parliamentary Constituency' as it also includes '2 Legislative Assembly Constituencies' of 'Ratnagiri District'.
- 7. The 'Revenue and Forest Department' therefore to cancel their 'Government Order' dated 12.02.2024 in respect of Applicant and allow her to continue on post of 'Deputy Collector, Kal Project, Tahsil Mangaon, District Raigad' as per entitlement under 'Section 3(1)' subject to 'Section 4(4)(ii)' and 'Section 4(5) of 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005'.

- 3. Learned P.O. thereupon produces the 'Office Copy (OC)' of 'Suspension Order' dated 04.07.2024 of Applicant which was issued by 'Resident Deputy Collector, Raigad'; but the 'Office Copy (OC)' bears 'Designation' & 'Signature' of 'Appointing Authority' & 'Disciplinary Authority' who is 'District Collector, Raigad'.
- 4. Learned P.O. also seeks time to ascertain whether the 'Suspension Order' dated 04.07.2024 of Applicant passed by 'District Collector Raigad' as 'Appointing Authority' & 'Disciplinary Authority' was is in contemplation of 'Departmental Enquiry' under 'Rule 8' or 'Rule 10' of 'Maharashtra Civil Services (Discipline & Appeal) Rules, 1979'.
