2 In the O.A. the Applicant is challenging the prospective operation of the G.R. dated 7.8.2012, Exh.'E'.

3 Learned Advocate for the Applicant states that even though the 6th Pay Commission has been applied from 1.1.2006 as per the G.R. dated 7.8.2012, non-practicing allowance sanctioned to the Applicants from 1.7.2012.

4 The Applicants have already been retired from service during February 2010 to April 2012 after commencing the force of 6th Pay Commissioner.

5 Learned P.O. for the Respondents strongly opposed to condone the delay on the ground that no specific reason has been mentioned for condoning the delay.

6 The Applicant however in para no.4 of the M.A. mentions that the Applicants had already been retired and about of old age and limitation they do not go through the G.R.

7 The question as to whether the benefits of 6th Pay Commission is due to the Applicants as per the G.R. dated 7.8.2012 or from the date of 1.1.2006 is to be considered on merit.

8 Considering the aspect the delay in filing O.A. is hereby condoned in the interest of justice and equity.


