- 2. The Applicant prays that this Tribunal be pleased to direct the Respondents to open the 'sealed cover' qua the Applicant in the meeting of the DPC held in December, 2021.
- The Ld. Advocate for the Applicant submits that the Applicant in this OA prays for promotion to the post of Superintendent of Land Records. He relies on Clause No.12-A and 12-C of G.R. dated 15.12.2017. He further submits that the Applicant is exonerated in appeal from DE on 07.07.2023. On 11.09.2023, the Respondents issued communication to all the eligible Government servants of Feeder Cadre of Deputy Superintendent of Land Records to submit their options. - 4. The Ld. C.P.O submits that the meeting of the D.P.O for the present promotion was conducted on 17.1.2023 and at the relevant time the applicant was not exonerated. His name was considered for the first time on 13.1.2021 for the select list of 2020-21 for promotion and his case was kept in 'sealed cover' and that 'sealed cover' is required to be opened. The applicant was exonerated of the charges on 7.7.2023. The proposal for promotion of the applicant on account of his exoneration was received from the Office of the Settlement Commissioner on 25.7.2023. Learned C.P.O on instructions from Mr. Sanjay Banker, Joint Secretary, Revenue & Forest Department, submits that the process of file regarding opening of the 'sealed cover' has been submitted to the
