- 2. This is High Court remanded matter which needs to be decided in view of the directions given by the Hon'ble High Court in judgment passed on 29.10.2018 in W.P 620/2015 with connected Writ Petitions.
- 3. This Tribunal has earlier disposed of this Original Application by judgment dated 2.4.2014 whereby entire selection process for the post of Clerk-Typist pursuant to the order dated 22.3.2008 was quashed and set aside.
