ORDER

1. Heard Shri A.V. Bandiwadekar, the learned Advocate for the Applicant and Shri A.J. Chougule, the learned Presenting Officer for the Respondents.
2. On the last date, the matter was adjourned in view of the letter dated 1.11.2018 written by Director of Vocation Education and Training, Maharashtra State to the Principal Secretary, Skill Development and Entrepreneurship Department, Maharashtra State to the effect that the issue of appointment on compassionate ground is under serious consideration as the appointments are given to other candidates who are similar situated persons. Accordingly two weeks' time was granted to the leaned P.O. to take appropriate decision and inform the Tribunal about the same, today.
3. Today, the learned P.O. for the Respondents has tendered letter dated 27.11.2018 issued by Desk Officer of Respondent No.3 to Respondent No.2. It shows that the directions were given to collect the information of all pending cases relating to appointment on compassionate ground and submit the proposal to Government accordingly.
4. As such, it appears that the matter is under process and it will be take some time.

5. Father of the Applicant died in harness in 2005. At appears that the claim of the Applicant for appointment on compassionate ground was earlier rejected which was communicated to the Applicant by letter dated 12.04.2013 on the ground that the deceased was in the pay scale of Rs.9300-34800 G.P. Rs.4300/- and therefore, the Applicant was not entitled for appointment on compassionate ground. However, this aspect seems to have been finally settled by higher judicial forum and hence the appointments on compassionate ground are given to similar situated persons. On the basis of it, now the Applicant has filed O.A. on 24.8.2018 for appointment on compassionate ground. Infact, in this proceeding the Applicant has challenged the order dated 22.2.2018 issued by Assistant Director as well as Information Officer, Vocation Education and Training under information of Right to Information Act.

6. Be that as it may, the Applicant now filed application before this Tribunal for appointment on compassionate ground on parity needs to be decided on merit expeditiously.

7. As per letter, today tendered by the learned P.O. it appears that the subject is under consideration of concerned authority and may take some time. As the subject matter is of appointment on compassionate ground, it needs to be expedited otherwise very purpose of filing of O.A. can be frustrated.

8. In this Original Application reply is not yet filed as the matter was under consideration before the concerned authority.

9. In view of above, learned P.O. is directed to file reply within two weeks without fail as well as take necessary steps pertaining to the matter which is already in process with the concerned department.

ORDER

1. Heard Shri A.V. Bandiwadekar, the learned Advocate for the Applicant and Smt. Archana B.K., the learned Presenting Officer for the Respondents.
2. The matter pertains to delay in releasing retiral dues in view of the objection in respect of increment granted to the Applicant though he has not passed Marathi Language Examination and recovery sought to be made from his retiral benefits.
3. However, today learned P.O. for the Respondents has tendered copy of letter dated 16.11.2018 issued by the office of Respondent No.1 addressed to office of Accountant General (A.G.) informing that the objection for not passing Marathi Language Examination has been waived and exemption has been granted to the Applicant by order dated 17.7.2018. It is further stated in the letter that, in pursuance of it Pay Verification has been done afresh and also got verified from Pay Verification Unit. Accordingly, A.G. was requested to approve the proposal and sanction the pension and other retiral dues. As such, in view of the order dated 16.11.2018, grievance of the Applicant is redressed.
4. Learned Advocate for the Applicant, however, submitted that the matter be kept pending so that the Applicant will get actual monetary benefits which are not received by the Applicant, yet.

5. Shri T.L. Bagadi, Senior Assistant, Office of the Manager Incharge, Central Dairy Aarey, Goregaon (E), Mumbai 65 on behalf of the Respondent No.1 is present and submitted that the proposal is already submitted to the office of A.G. and it will be sanctioned shortly.

6. In view of the above, I do not think it necessary to keep the matter pending as the proposal is already submitted to the office of A.G. and it will be sanctioned soon.

7. As such, there is no point to keep the matter pending on the file and it is disposed of with directions to the Respondent to take follow-up of the pension proposal submitted to the office of A.G., get it sanctioned and the monitory benefits be actually released within two months from today. Failing which, the Respondents will be liable for interest as per rules.

Today, learned P.O. on instructions received from Shri Ravindra Gote, Under Secretary, Public Health Department submits that now steps are being taken for placing the matter before the review committee and necessary decision would be taken in due course. 5. What has transpired is that though the Applicant is under suspension for more than two years, no steps are taken about the review of suspension as mandated ^{Memo filed} by the Government Resolution and nor charge sheet is filed. Therefore, matter needs to be expedited. 6.
