- 2. There is delay of 02 years and 06 months caused in filing the accompanying Original Application.
- 3. Learned counsel for the applicant submits that the husband of the applicant was working as Supervisor in the Education Department and during his service tenure he got 1st benefit of Assured Career Progression Scheme (for short 'ACPS). However, 2nd benefit of ACPS is concerned, G.R. dated 01.04.2010 was issued by the Government by giving back effect to the same from the year 2006. Learned counsel, however, submits that in the year 2011 the husband of the applicant has suffered from paralysis attack and he remained bedridden from the year of 2011 till the year 2015. In the month of

July, 2015 husband of the applicant died. In the year 2015 itself the applicant got family pension. The applicant has filed another O.A. bearing No. 128/2016 before this Tribunal challenging recovery of certain amount from the pensionary benefits and the said O.A. was allowed by this Tribunal vide order dated 02.09.2016. Learned counsel submits that delay occasioned in filing the accompanying Original Application is not intentional and deliberate. Applicant is seeking remedy in connection with the rendered by her services husband while Government service and said relief is monetary relief not affecting interest of any third party. As such, learned counsel submits that there is no inaction on the part of the applicant. In the circumstances, learned counsel submits that delay may condoned.

4. Learned Presenting Officer has strongly resisted the Misc. Application. Learned P.O. submits that husband of the applicant during his service tenure had never requested for second benefit of ACPS and even after his death the applicant, though approached this Tribunal against certain actions taken by the department of recovery of certain

amount from the pensionary benefits, cannot be said to have no knowledge about the legal provisions. Learned P.O. submits that Original Application suffers from delay and laches. There is total inaction on the part of the husband of the applicant and also on part of present applicant herself. Learned P.O., therefore, submits that the M.A. seeking condonation of delay is thus, liable to be dismissed having no substance.

5. It appears that the applicant is claiming certain which ultimately have consequence on reliefs monetary benefits not affecting rights of any third Further it appears that husband of the party. applicant has suffered with paralysis attack in the year 2011 and he remained bedridden till year 2015. In the month of July, 2015 husband of the applicant died. Though second benefit of ACPS was due in the year 2008, however, as rightly pointed out by learned counsel for the applicant, in view of G.R. dated 01.04.2010 Government has given effect to the second benefit of ACPS after the period of 24 years to the concerned employees from the year 2006. view of the same, though there is inordinate delay in approaching this Tribunal, however, the said delay is

not intentional and deliberate one. There is no inaction on the part of the applicant. Considering all aspects of the matter we are inclined to condone the delay caused in filing the accompanying O.A., subject to certain costs to be paid by the applicant. Hence, the following order: -

ORDER

- (i) The Misc. Application No. 609/2019 is hereby allowed.
- (ii) The delay of 02 years and 06 months caused in filing the accompanying O.A. under Section 19 of the Administrative Tribunals Act, 1985 is hereby condoned, subject to payment of costs of Rs. 1000/- (One Thousand Only) to be paid by the applicant. The amount of costs shall be paid to the M.A.T. Bar Association within a period of one month from the date of this order.
- (iii) Upon satisfaction of the costs as above, the accompanying O.A. be registered and numbered by taking in to account other office objection/s, if any.
- (iv) The M.A. accordingly disposed of.
