- 2. Record shows that in spite of grant of many opportunities, the affidavit in reply is not filed on behalf of respondents in M.A.
- By this Misc. there is delay of about 1 year, 3 months and 17 days caused in filing the accompanying O.A.

7. It is a settled principle of law that the expression "sufficient cause" is to be construed liberally. From the facts and circumstances, some negligence can be attributed to the applicant for taking necessary steps for collecting documents in time. However, the delay cannot be said to be deliberate and intentional. Thereby the applicant had nothing to gain. In view of the same, in my considered opinion, this is a fit case to condone the delay by imposing the moderate costs of Rs. 1,000/- on the applicant. Hence, I proceed to pass following order:-

ORDER

- 2. It is the contention of the applicant that on the basis of the recommendation of 'Shri Laad Page Committee' having regard to his educational qualification he must have been given appointment to the post of Group Instructor, whereas he has been given appointment on the post of Instructor.
- 3. Learned Presenting Officer pointed out that the applicant had filed an application on 15.9.2012 seeking compassionate appointment and in the said application itself applicant had claimed the appointment on the post of Instructor and he resumed on the said post without raising any grievance. Learned Presenting Officer has submitted that the applicant is, therefore, estopped from raising grievance that any injustice has been caused to him.
- 4. We have perused application submitted by the applicant to the Collector, Parbhani on 15.9.2012. It is

true that in the said application the applicant himself has claimed appointment on the post of Instructor. As per the recommendations of Shri Laad Page Committee if the legal heir or nominee of any deceased class-IV employee, more particularly Sweeper and if the said legal heir or nominee is duly qualified he can be given an appointment also on any class-III post. It is not in dispute that the post of Instructor is a Class-III post and the applicant was possessing the necessary qualification for to be appointed on the said post.

- 5. In the aforesaid circumstances, it does not appear to us that any case is made out by the applicant for grant of any relief as claimed by him in the present O.A. The O.A. being devoid of any substance deserves to be dismissed and is accordingly dismissed. In view of the dismissal of O.A., the contempt petition and the miscellaneous applications arising thereof also stand disposed of. There shall be no order as to costs.
- 6. The applicant may compete for the promotional post as and when occasion arises and if he is found eligible his case may be considered on merit by the respondents.

- 2. The applicant was appointed as Shikshan Sevak w.e.f. 16.09.2009. He belongs to S.T. category (Koli-Mahadeo). The applicant was posted to serve at Government Ashram School at Mohpur, Tq. Mahur as per the appointment letter dated 24.8.2009. Prior to resuming duties of Shikshan Sevak the applicant had obtained the admission for B.Ed. course. The applicant completed B.Ed. course on 10.6.2010. After completing the period of three years as Shikshan Sevak the applicant was appointed as Primary Teacher at the same Ashram School w.e.f. 18.9.2012. The pay scale was also made applicable to him of the said post from same date i.e. 18.9.2012.
- 3. In the present application it is the grievance of the applicant that he has been wrongly denied the Graduate Teacher's pay scale though the same has been made applicable to some of the primary teachers junior to him.

The relevant seniority list is placed on record by the applicant.

- 4. The respondents in the affidavit in reply filed by them have contended that the applicant while entering into the Government service suppressed the fact that he had taken admission for B.Ed. course. It is the further contention of the respondents that for completing the said B.Ed. course the applicant had taken long leave and he remained away from the duty for about 64 days. It is the further contention of the respondents that the period of said 64 days was treated as leave without pay and considering the facts as aforesaid the relief as has been claimed by the applicant has not been given to him. According to the respondents, no illegality or irregularity has been committed by the respondents. The respondents have, therefore, prayed for dismissal of the O.A.
- 5. Learned counsel appearing for the applicant submitted that the applicant had never suppressed the fact that he was undergoing the B.Ed. course while he was appointed on the post of Shikshan Sevak. Learned counsel submitted that in the application submitted by the applicant seeking leave at the relevant time he has honestly mentioned the reason that he was taking leave for appearing to the B.Ed. examination. Learned counsel

further submitted that at the relevant time no objection was raised neither any action was taken against the applicant and after completing the period of three years on the post of Shikshan Sevak the applicant was appointed on the post of Primary Teacher w.e.f. 18.9.2012. The appointment order is placed on record as Annexure 'A-5'. From 18.9.2012 the regular pay scale of the post of Primary Teacher was made applicable to the applicant.

6. From the pleadings in the affidavit in reply filed by the respondents and documents, which are filed on record it is revealed that some complaints were received in respect of some teachers including the present applicant, who have completed their B.Ed. course while in service. The respondents have placed on record some documents in that regard. It appears that the complaints were received in respect of about 7 such teachers. The committee consisting of 3 members submitted the report in that Additional Commissioner. regard to the Triba1 Development, Amravati. We have gone through the said report. Reading of the said report apparently revealed that in case of the present applicant though finding has been recorded that the applicant is found guilty of completing B.Ed. course while in service and without taking any permission therefor. No further action is, however proposed against the applicant, as well as, some other teachers, whereas from the contents of the report itself it

reveals that in respect of some of the teachers, action was suggested.

- 7. Learned counsel for the applicant invited our attention to the report in respect of Shri A.R. Shinde (page-74 of the paper book). In respect of said Shri Shinde the enquiry committee has recorded a finding that Shri Shinde had made an application seeking permission for appearing B.Ed. examination, but the Project Officer did not take cognizance of the said application in the reasonable period. It is further noted that since Shri Shinde had taken without pay leave for appearing in the B.Ed. examination during the period when he was working on the post of Shikshan Sevak and accordingly his service period as Shikshan Sevak was extended by the number of days on which he was on leave, it cannot be said that said Shri Shinde has obtained B.Ed degree while on duty. It is the contention of the present applicant that while considering his case unequal treatment has been given to him than given to Shri Shinde. According to the applicant, he has been thus discriminated.
- 8. We find substance in the allegation so made by the applicant. From the documents on record, it is clear that the applicant had also obtained leave for appearing for the examination of B.Ed. The documents on record further show that 64 days period of his absence was treated as

leave without pay and for taking note of the said fact the Headmaster of the Ashram School Mohpur, Tq. Kinwat, Dist. Nanded had written a letter to the Project Officer on 28.4.2010, wherein it was specifically disclosed that the applicant had remained absent for the purpose of appearing in the examination of B.Ed. It, therefore, cannot be said that the applicant had intentionally suppressed the said fact or has not disclosed the said fact.

- 9. In the aforesaid circumstances, it appears to us that the respondents shall consider the case of the applicant in the manner they have considered the case of Shri A.R. Shinde. Having regard to the fact that the applicant remained away from duty for about 64 days while he was working as Shikshan Sevak, the service period of the applicant on the post of Shikshan Sevak can be reasonably extended by 64 days. In turn, the appointment given to the applicant on the post of Primary Teacher shall be deemed to have issued 64 days later than it was given to him and treating the said date as the date of initial appointment of the applicant on the post of Primary Teacher the case of the applicant be considered for extending the benefit of graduate pay scale to him alike Shri A.R. Shinde, if the applicant is found otherwise entitled for the said pay scale.
- 10. Respondents shall complete the aforesaid exercise within 3 months form the date of this order.
