- 2. The Applicant has challenged the transfer order dated 31.05.2023 whereby he is transferred from Raigad, Alibag to Galhati, Jalna *inter-alia* contending that he is transferred midterm and mid-tenure in contravention of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005. Learned Counsel for the Applicant, therefore, prayed for interim relief.
- 3. The Applicant is serving as Assistant Fisheries Development Officer and was posted at Raigad, Alibag by order dated 30.08.2021. Thus, in terms of provisions of Transfer Act, 2005, he is entitled for three years tenure. - 5. The impugned order dated 31.05.2023 is thus midterm and mid-tenure transfer which requires approval of next higher competent authority. As per Section 6, Head of the Department is competent authority for general transfers of

As such, the Commissioner is competent authority for general transfers and for mid-term and midtenure transfers, the Minister in Charge in consultation with Secretary of the concerned department is the competent authority. In present case, admittedly, there is no approval of Minister in Charge. The Secretary's approval has no sanctity in the eye of law so as to render the transfer order legal and valid. Thus, *prima-facie*, the transfer order is not in compliance of Transfer Act, 2005 and requires to be stayed.

- 6. For the aforesaid reasons, interim relief in terms of prayer clause 10(a) is granted.
