In the present O.A., the Applicant has challenged the transfer order dated 19.07.2019 whereby he is transferred from Mangaon, Dist. Raigad to Kalambani, Dist. Ratnagiri on the ground that it is not in consonance with Section 4(4)(ii) and 4(5) of the Section 4(4)(ii) and 4(5) of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter referred to as 'Act 2005'). The Applicant, therefore, prayed for interim relief.</p> <p>3. Learned P.O. for the Respondents has tendered a file for perusal of the Tribunal which shows that the transfers were recommended by the Civil Services Board on 11.06.2019 and the same was approved by the Hon'ble Minister as well as Hon'ble Chief Minister.</p> <p>4. However, no reason for administrative exigency is forthcoming for such mid-term transfer. Though the Applicant was due for transfer, the transfer order being issued on 19.07.2019, it falls within the category of mid-term transfer which required compliance of Sections 4(4)(ii) and 4(5) of the 'Act 2005'. Interestingly in impugned transfer order, the Applicant is shown transferred on request. However, the perusal of file produced by the learned P.O. does not show any such request letter or representation of the Applicant. As such, prima-facie, no special reason or administrative exigency is seen so as to justify the mid-term</p>

5. In view of above, I am satisfied that prima-facie the impugned transfer order is not in consonance with Section 4(4)(ii) and 4(5) of the 'Act 2005' and the same deserves to be stayed.

6. For the aforesaid reasons, interim relief as per prayer clause 10(a) is granted.

7. Issue notice before admission returnable on 03.09.2019.

8. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

9. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A.. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

10. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

11. The service may be done by Hand delivery, speed post, courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.

12. In case notice is not collected within seven days or service report on affidavit is not filed 3 days before returnable date, Original Application shall stand dismissed without reference to Tribunal and papers be consigned to record.
