ORDER

1. Heard Shri A.V. Bandiwadekar, the learned Advocate for the Applicants and Ms. S.P. Manchekar, the learned Chief Presenting Officer for the Respondents.

2. By the order dated 23.8.2018, Exh. 'A', page no.21 the Applicant has been transferred from the post of Deputy Collector, S.D.O. Satara to Sangli in the place of Respondent No.2.

3. Though the Applicant has been relieved from the post, the Respondent No.2 has not yet joined at Satara. The Applicant, therefore, claims that impugned order be stayed and the Applicant be allowed to work at Satara.

4. Learned Advocate for the Applicant submits that even though in the order it has been stipulated that it has been passed as per the provision of 4(4) and 4(5) of the transfer act, 2005, no specific reasons have been given except that this order has been passed due to administrative reasons.

5. Learned Advocate for the Applicant placed reliance on the judgments of this Tribunal in O.A.No.1137 of 2016, O.A.No.450 of 2017 and O.A.Nos.453 to 456 of 2017. This Tribunal has expressed judicial view and also directed that concerned Applicants to be continued in service at that post, inspite of the fact that they were released.

6. Learned C.P.O. for the Respondents submits that the provision of the transfer act has been followed and the Respondents want to file reply affidavit.

7. According to the learned Advocate for the Applicant, the Applicant is undergone training as ERO and also he stood at merit in the said training. Therefore, if the , pplicant is shifted Government may be put at loss.

8. The Applicant has also submits that Applicant's son is taking education at 10^{th} S' J. and this fact was put to the notice of Collector Satara which is Exh. 'I', page no.37 of the p-per block. She requested the Collector not to relieve her. It is, however, clear that the said representation is not addressed to the Government and Collector is not a authority to consider the request of the Applicant since the transfer order has been passed by the Government.

9. Admittedly, the Respondent No.2 has yet not joined at Satara in place of the A₁ plicant and said post is still vacant. Learned C.P.O. for the Respondents states that the due rocedure has been followed for transferring and it will be in the interest of justice to give an o portunity to file reply affidavit. She further submits that the matter be kept on 14.9.2018 or that date reply will be filed positively.

10. In view thereof reply shall be filed on that that positively and in the meantime F esponder No.1 is directed not to insist Applicant to join at Sangli as per the order dated 23.8.2018.

11. The Applicant will be liberty to file separate representation for her retention to Satara for one year considering education problem of her children.
