- 2. I have heard the arguments advanced by the learned Advocate for the applicant substantially.
- 3. During the course of arguments, it is noticed that additional affidavit is filed by the applicant, which is at page no.66 of paper book. In the said additional affidavit, the applicant has categorically stated that amongst others almost all the incumbents have been accommodated by the respondent no.4 at or near by Nagpur. Thereby he refers to the impugned order dated 30.06.2018 (Annex 'A-2', page nos.14 & 15 of paper book of O.A.) whereby in all 40 police officials from constabulary have been transferred. However, it seems that the said contention is not substantially dealt with in subsequent affidavits filed by respondents which are at page no.68 and 75.
