Pune with all consequential service benefits.
- 3. Private Respondent No.5 has appeared in person and he has opposed the request prayed by the Applicant to allow the Applicant to continue on the same post as he has already handed over the charge of Sub Divisional Police Officer, Nashik Rural on 28.08.2024. Copy of relieving memo dated 28.08.2024 is filed along with the affidavit-in-reply dated 04.09.2024 filed by Private Respondent No.5. Private Respondent No.5 also pointed out diary entry dated 29.08.2024 that he has taken charge as Sub Divisional Police Officer, Daund.
- Learned Counsel for the Applicant Ms. Mahajan has submitted that the Applicant has not completed the requisite tenure of two years on the present post as he was promoted to the post of Deputy Superintendent of Police on 13.10.2023 and posted at Solapur Rural. Learned Counsel has further submitted that the Applicant has made representation on 08.08.2024 that the Applicant be posted in functional Department in Pune, so that the directions given by the Election Commission dated 31.07.2024 will not be applicable to the Applicant for transfer. She has pointed out that these directions are mentioned in paragraph 5.3 of the guidelines of Election Commission dated 31.07.2024. Learned Counsel has submitted that the transfer order of the Applicant is passed in violation of Section 22N of the Maharashtra Police Act as the Applicant has not completed the requisite tenure of two years at his present post in Pune.

Tribunal's orders

- 5. Per contra, Private Respondent No.5 has pointed out Clause 3 of the directions given in the guidelines of Election Commission of India dated 31.07.2024, which states that, if any, officer has competed total three years in that district during last four years or would be completing three years on or before 30.11.2024 for Maharashtra, then the person is liable to be transferred. Private Respondent no.5 has further pointed out that even for calculating the period of three years spent on promotion to the post within a District is also to be counted in those three years period.
- 6. Learned P.O. has submitted that the representation made by the Applicant is under consideration by the Department.
- 7. Considered submissions. The directions issued by the Election Commission of India dated 31.07.2024 are the first prerogative over other transfer laws. Applicant has put in total three years during the last four years in District Pune on transferable post as per the guidelines mentioned in Clause 3 which read as below:
 - "3. Hence, the Commission has decided that no officer connected directly with elections shall be allowed to continue in the present district (revenue district) of posting:-

(i) if she/ he is posted in her / his home district.

(ii) if she/he has completed three years in that district during last four (4) years or would be completed 3 years on or before 30th September, 2024 for UT of Jammu and Kashmir, 31st October, 2024 for Haryana, 30th November, 2024 for Maharashtra and 31st December, 2024 for Jharkhand;

While calculating the period of three years, promotion to a post within the district is to be counted."

8. Applicant was never posted in functional Departments in these three years, in last four years. Therefore the impugned order passed by the Respondent-State cannot be faulted with. Therefore, I pass the following order:

ORDER

- (A) Order dated 28.08.2024 directing that the Applicant be continued at his post at Pune is hereby withdrawn and Respondent No.5 is directed to take charge of the said post immediately today itself.
- (B) As per the submissions made by learned P.O. representation of the Applicant is pending with the Government, the same may be considered and order be issued within a period of two weeks.
- (C) No further indulgence is required.
- (D) O.A. stands disposed of.
