Heard Shri V.B.Wagh, learned Counsel for the applicant and Shri V.R.Bhumkar, learned Presenting Officer for the respondent authorities.

- 2. When the present matter is taken up for consideration, learned P.O. has again sought time to file affidavit in reply to the M.A. The record shows that time was granted till today vide order passed on 23-03-2023 and the matter was directed to be placed High on Board indicating that even if the reply is not filed M.A. will be considered. Since the respondents have failed in filing reply to the M.A., present application is being heard without reply of the respondents.
- 3. Shri Wagh, learned Counsel for the applicant submitted that order dated 18-01-2023 whereby the respondent no.3 had discontinued the services of the applicant is wholly illegal and unsustainable.

Learned Counsel submitted that in the O.A.No.681/1994 filed by the present applicant way back on 20-02-1995 an order was passed by the Tribunal directing the respondent no.2 to not to fill the post by another ad-hoc candidate if no regular appointment is to be made, meaning thereby that in such event the services of the applicant be continued till the regularly selected candidate is appointed on the said post. Learned Counsel submitted that on the strength of the aforesaid order, applicant was continued till 18-01-2023.

4. Learned Counsel submitted that in the meanwhile, the applicant preferred the present O.A. seeking regularization of his services and during the pendency of the O.A., the impugned order has been passed. Learned Counsel submitted that no candidate selected by the Maharashtra Public Service Commission (MPSC) has been posted in place of the applicant in respondent no.3 Medical College. Learned Counsel further submitted that the respondents have misinterpreted the order passed by the Tribunal on 20-02-1995. Learned Counsel submitted that the impugned order could

have been justified had any candidate from MPSC would have been appointed on the said post. Learned Counsel in the circumstances has prayed for staying the effect and operation of the said order and further directions to the respondents to continue the applicant on the said post.

- 5. Learned Counsel submitted that though the applicant has been selected by MPSC and has been posted at G.T. College & Hospital at Mumbai, he is not willing to join on the said post. Learned Counsel submitted that if the terms and conditions in the appointment order are perused, it is quite obvious that the said appointment will be a fresh appointment and the applicant will be getting at the most 5 to 6 years on the said post and his earlier service of 28 years rendered with respondent no.3 College will not be considered for any purpose. Learned Counsel submitted that the circumstances, in the interest of justice present M.A. deserves to be allowed.
- 6. Shri Bhumkar, learned P.O. opposed for granting any such relief as has been prayed for by the applicant. Learned P.O. submitted that no one

has been appointed in place of the applicant in respondent no.3 College. He further submitted that there is no possibility of making any appointment even in future as there is no requirement of such post in the said College. Learned P.O. submitted that the applicant has now been selected through MPSC and having regard to the said fact he has been relieved from respondent no.3 College to facilitate his joining at the place of his posting. Learned P.O. submitted that the respondents have not at all acted contrary to the order passed by this Tribunal on 20-02-1995. As such, according to the learned P.O. no case is made out for grant of interim relief as has been prayed for by the applicant. He, therefore, prayed for rejecting the M.A.

7. I have duly considered the submissions advanced on behalf of the applicant as well as the State authorities. I have also perused documents on record. It is not in dispute that the applicant is working with respondent no.3 College on the post of Biochemist since the year 1994. It is also not in dispute that, as referred hereinabove, the applicant had earlier filed O.A.No.681/1994 wherein Tribunal

has given certain directions. It is further not in dispute that on the strength of the said order the applicant was continued in the services of the respondent no.3 till 18-01-2023. It is also not in dispute that the Government issued an advertisement for filling in the posts of Biochemists. In pursuance of the said advertisement applicant also applied for the said post and has also been There is further no dispute that the selected. applicant has been posted at G.T. Hospital Mumbai vide order dated 20-12-2022. The applicant has admittedly not resumed the duties on the said post.

8. It is the contention of the learned Counsel for the applicant that the respondents misinterpreting the order passed by the Tribunal. Learned Counsel submitted that the order does not say that if the applicant is selected through Maharashtra Public Service Commission (MPSC) he shall be discontinued from his post. The order in clear terms mandates that till a regularly selected candidate is appointed on the post on which the applicant was working at the relevant time, no other ad-hoc candidate shall be substituted. Learned

Counsel submitted that since no one has been appointed on the post on which the applicant was working, there was no reason for the respondents to discontinue the services of the applicant. Learned Counsel further submitted that there is valid reason for the applicant in not joining the new post as joining on the said post on the terms and conditions as are mentioned in the letter of appointment would amount giving up the right accrued in favour of the applicant for consideration of his past service of 28 years discharged by him in the respondent no.3 College. As against it, it has been argued by learned P.O. that there is every justification for passing the impugned order for two reasons; first that, the applicant has been selected by MPSC and further that respondent no.3 is not intending to appoint anybody in place of the applicant.

9. After having considered the submissions as above, it is difficult to accept the request as has been made by the applicant. It is true that, the application filed by the applicant seeking regularization of his services is pending before this Tribunal. It is also true that the applicant has

rendered services with the respondent no.3 for the period of 28 years. It is also true that the applicant has been given salary in pay scale and all other benefits as if he was a regularly selected candidate. It is also true that in the period between 1994 to 2022 no one was appointed on the post of the applicant on the recommendation of the MPSC. Inspite of the facts as aforesaid, in light of the submissions made on behalf of the State authorities that they are now not intending to appoint anybody on the post of the applicant, respondents cannot be compelled to retain the applicant or the services of the applicant cannot be foisted upon respondents.

10. The order passed by this Tribunal in the year 1995 on the basis of which services of the applicant were continued from time to time, cannot be interpreted to mean that in no case the applicant shall be discontinued. Perusal of the order would reveal that if the respondents choose not to appoint anybody they cannot be compelled to give appointment to the applicant on the said post. Only

restriction imposed on the respondents is that they cannot appoint anybody else than the present applicant till the regularly selected MPSC candidate becomes available. If the respondents have decided not to appoint anybody in place of the applicant, they cannot be compelled to continue the present applicant on the said post.

11. In so far as the decision taken by the applicant not to join on the post after his selection through MPSC, it can only be said that it is the choice of the applicant whether to join or not to join the post. Only question remains what would be the fate of the O.A. filed by the applicant. It has to be clarified that the said application will be considered on its own merits having regard to the facts and circumstances and more particularly the fact that the applicant has rendered 28 years of service on the said post. However, no case is made out for accepting the request of the applicant made in the present M.A. In the circumstances, following order is passed:

ORDER

[i] M.A.No.43/2023 is rejected.

[ii] It is, however, clarified that in the event respondents choose to appoint some candidate other than selected by MPSC, in such case, it will be mandatory on the part of the respondents to appoint applicant and none else.

- 2. The applicant has preferred the present O.A. challenging the order of recovery directed from the retiral benefits of the applicant on the ground of excess payment made to the applicant. Learned Counsel submits that the applicant has retired from the Government services on 31-03-2022 on attaining the age of superannuation. At the time of his retirement neither any departmental enquiry was pending nor criminal case was pending against the applicant. No dues certificate was also issued in favour of the applicant. Learned Counsel in the circumstances while seeking issuance of notice to the respondents has also prayed for staying the effect and operation of the impugned order thereby staying recovery.
- 3. Learned P.O. has sought time to file affidavit in reply on behalf of the respondents. Learned P.O submits that for want of instructions he is unable to make any submission on the request made by the applicant for

stay to the recovery. Learned P.O., however, opposed for granting any stay. Learned P.O. invited my attention to the document at paper book page 16. Learned P.O. submitted that while revising pay it has been specifically mentioned that the pay has been fixed subject to the verification by Pay Verification Unit and further that if it is noticed that if any excess payment is made, same is liable to be recovered. Learned P.O. submitted that the applicant is well aware of the said fact and in the circumstances he has prayed that no stay be granting in the matter.

- 4. After hearing the learned Counsel for the applicant and the learned P.O. and after having gone through the documents filed on record, it appears to me that the applicant has certainly made out a *prima facie* case. At this juncture, nothing can be stated about veracity of the pay verification as has been done by the Pay Verification Unit and further that whether the applicant has given any undertaking in that regard.
- 5. In the circumstances, issue notices to the respondents, returnable on 28.06.2023. Till then, respondents shall not effect any recovery in pursuance of the order impugned in the present O.A.

- 6. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

- 5. Death certificate produced on record would show that the original applicant Rekha Ashok Bonalwar died on or about 16.08.2022. Birth certificate of the applicant would show that he was born on 8.6.2008. Hence, as on making of this Misc. Application on 20.01.2023, he was about 14 years old. Ration card of Shri Ashok Lacchmanna Bonalwar would show that the original applicant Rekha and the guardian Sanjivani through whom this application is made are real sisters. There is no conflicting interest between the applicant and his guardian Smt. Sanjivani, through whom this application is made. Considering the nature of proceedings, right to sue would survive in the

applicant, who is minor son of original application, who has claimed family pension. No doubt there is delay in making application. However, the delay cannot be said to be intentional or deliberate one. Hence, the following order:-

ORDER

- (ii) The delay in making the application is hereby condoned. The abetment order is quashed and set aside. The name of the applicant is allowed to be brought on record as legal representative of deceased applicant through his next friend/guardian, who is maternal aunt. - 3. It is stated that the Advocate was not aware of the death of the original applicant, as there was no communication with him. The delay is not deliberate or intentional.

- 4. We have heard the arguments advanced by Shri C.A. Shingare, learned Advocate for the applicant on one hand and Shri V.R. Bhumkar, learned Presenting Officer for the respondents on the other hand.
- 5. Perusal of the death certificate would show that the original applicant viz. Tukaram Suryabhan Jagtap died on 26.06.2021. Heirship certificate produced on record would show that the applicants are heirs and legal representatives of the deceased applicant viz. Tukaram Suryabhan Considering the nature of proceeding, right to sue would survive in the applicants. No doubt there is delay in making the application and therefore, the original proceedings got abated. However, the said delay cannot be said to be intentional or deliberate one. It is stated that the Advocate of the applicant was not aware about the death of the original Applicant. In view of the same, liberal view is required to be taken. Hence, the following order:-

ORDER

(1) M.A. No. 578/2022 is allowed.

3. It is stated that the applicant made representation dated 20.12.2016 (Annexure A-16 in O.A.) seeking benefits in view of the judgment and

order dated 28.04.2016 passed by the Hon'ble High Court in W.P. No. 9051/2013 in the matter of The State of Maharashtra Vs. Smt. Meena A. Kuwalekar and other W.Ps. The accompanying O.A. was filed on 28.02.2022, whereas the present Misc. Application for condonation of delay is filed on 13.04.2022. There is delay. It is contended that the delay is not deliberate or intentional one. There is merit in the O.A. Similar O.As. are allowed by this Tribunal. Hence the present Misc. Application.

- 4. The affidavit in reply is filed on behalf of respondent Nos. 1 to 4 by one Uttam Narayan Sonkamble, working as the Joint Director Account and Treasuries Aurangabad Division Aurangabad, thereby he denied all the adverse contentions raised in the M.A. and stated that no sufficient cause is shown by the applicant for condonation of delay.
- 5. We have heard the arguments advanced by Shri K.B. Jadhav, learned Advocate for the applicant on one hand and Shri N.U. Yadav, learned Presenting Officer for the respondents on the other hand.

6. Considering the facts on record, in our considered opinion, the case of the applicant is required to be considered on merits in view of the various decisions of this Tribunal, as well as, the Hon'ble High Court regarding counting of qualifying service for the purpose of ACPS. It is a settled principle of law that the expression "sufficient cause" is to be construed liberally. In the facts and circumstances as above, refusing to condone the delay is likely to defeat the cause of justice at the threshold. In the circumstances, in our considered opinion, this is a fit case to condone the delay by imposing the moderate costs of Rs. 1,500/- on the applicant. Hence, we proceed to pass the following order :-

ORDER

The Misc. Application No. 171/2022 is allowed in following terms:-

(i) The delay of 3 years and 9 months caused for filing the accompanying O.A. under Section 19 of the Administrative Tribunals Act, 1985 is hereby condoned

By this Misc. Application the applicant is seeking condonation of delay of about 15 years caused in filing the accompanying O.A.

2. The Original Application is filed seeking direction to the respondents to treat the applicant's date of appointment on permanent basis as 12.12.1995 as per the order passed in Review Application No. 29/2021 in O.A. No. 410/2000 & 384/2000 dated 02.07.2003 by this Tribunal and grant him pay and allowances for the said date till the date of his regularization and to direct the respondents to count the temporary / ad-hoc service rendered by the applicant as qualifying service as per Rule 30 of M.C.S. (Pension) Rules, 1982 and to grant him other consequential benefits and further to direct the respondents to decide the various representations made by him in the year 2021.

3. The applicant belongs to project affected person category and is holding the requisite certificate in that respect dated 26.6.1995. The applicant passed B.Sc. in the year 1993 and also passed DMLT Course. He also belongs to OBC category. He was holding caste certificate and caste validity certificate. On his application, he was appointed on the post of Laboratory Technician in the year 1995 initially on temporary basis for six months and subsequently in the year 1997. As the applicant was got temporary appointment, he filed O.A. 384/2000 for continuity of service. By interim order dated 16.6.2000, the respondent No. 3 issued appointment order dated 29.06.2000. The said O.A. No. 384/2000 along with O.A. No. 410/2000 filed by similarly situated person namely Shri Ashok Baliram Pawar were decided on 04.05.2001 (Annexure A-11 in O.A.), thereby directing to continue in service with technical breaks until they are replaced by regular selected candidates and if vacancies arose in the quota meant for project affected persons, they may be considered preferentially in those vacancies for regularization.

- 4. The applicant in O.A. No. 410/2000 viz. Ashok Baliram Pawar filed Review Application No. 29/2001, which came to be allowed by this Tribunal by the order dated 02.07.2003 (Annexure A-13 in O.A.), thereby order dated 04.05.2001 commonly passed in O.A. Nos. 384/2000 and 410/2000 was modified as follows:-
 - "9. In the light of the above, we hold that the review application deserves to be considered and we hereby modify para 1 of the order dated 4.5.2001 as follows.

"The date on which the application of the applicant was first made and forwarded should be considered as the relevant date and not the recommendations made by the committee constituted for the purpose. In the case of applicant in O.A. 410/2000 the application of the applicant dated 6.7.1988 has been forwarded for the first time and this date should be taken as the relevant date. Accordingly, he is entitled to be considered by the Respondents for his appointment as Laboratory Technician on a permanent basis. The applicant in O.A. 384/2000 should also be considered on the same basis."

5. In view of above, Shri Ashok Baliram Pawar filed O.A. St. No. 456/2020 along with M.A. No. 215/2020, seeking reliefs which are prayed for by

the applicant in the present O.A. The delay in his O.A. is condoned as per the order dated 15.03.2022 i.e. during pendency of this M.A. along with accompanying O.A. Hence, the present M.A.

- 6. No affidavit in reply is filed filing in this M.A., though several opportunities were given to the respondents.
- 7. We have heard the arguments advanced by Shri K.B. Jadhav, learned Advocate for the applicant on one hand and Shri B.S. Deokar, learned Presenting Officer for the respondents on the other hand.
- 8. Perusal of the order dated 15.03.2022 passed in M.A. No. 218/20220 in O.A. St. 456/2020 would show that the same was filed by Shri Ashok Baliram Pawar referred in the present proceeding. In this order, the delay is condoned. In such circumstances, in our considered opinion, it would be just and proper to take a similar view, as the applicant falls under the category of similarly situated person. In the facts and circumstances, the contentions

raised by the applicant in this O.A. requires further consideration. The delay is considerable period. However, in the interest of justice and in order to give fair opportunity to the applicant, it would be just and proper to condone the delay by imposing the moderate costs of Rs. 2000/- on the applicant. Hence, we proceed to pass the following order:-

ORDER

The Misc. Application No. 97/2022 is allowed in following terms:-

(ii) The delay of 15 years caused for filing the accompanying O.A. under Section 19 of the Administrative Tribunals Act, 1985 is hereby condoned subject to payment of costs of Rs. 2000/- by the applicant. - 2. The present Original Application is filed seeking direction to the respondent Nos. 1 to 4 not to take coercive action against the applicant like compulsory retirement on the basis of impugned letter dated 16.02.2023 (Annexure A-6) forwarded by the respondent No. 3 to respondent No. 2 considering the mandatory proviso clause of Section 20(4) of the Rights of Persons with Disabilities Act, 2016 and to quash and set aside the said impugned letter.
- 3. In the facts and circumstances, the applicant has prayed for interim relief in terms of para VI(A), which is as follows:-

"VI) INTERIM RELIEF SOUGHT

A. Pending hearing and final disposal of the original application, effect and operation of impugned letter dated 16.02.2023 issued by the respondent No.3 to respondent No.2 may

kindly be stayed and considering the provisions of Sec.20 (4) of the Rights of Persons with Disabilities Act, 2016 regular monthly salary from June- 2022 onwards may kindly be directed to pay and further to pay regular monthly salary to applicant."

- 4. The applicant has completed 19 years of service in Forest Department. At present he is working as Range Forest Officer at Kannad Division under the authority of respondent No. 3 i.e. the Chief Conservator of Forest (Territorial) Aurangabad, Van Bhawan Osmanpura, Aurangabad, Dist. Aurangabad. It is class-II post. As per rules of the Forest, he is having supervisory powers and administrative function.
- 5. It is contended that during the service the applicant said to have suffered disability of partial blindness. In June, 2022, the applicant was transferred from Nandurbar to Aurangabad at Kannad Division as Range Forest Officer. He joined on that post on 22.06.2022. The applicant was on Medical Leave from 30.06.2022 to 29.08.2022. He suffered in Covid-19 pandemic and his health was badly affected in respect of vision. Since July 2022 onwards, regular monthly salary of the applicant is withheld.
- 6. Initially the applicant was referred to Medical Board, Medical College and Hospital, Aurangabad for

medical check-up. 'Nil' report was given in respect of the applicant's vision. The applicant was again referred to JJ Hospital, Mumbai by Medial Board, Government Medical College and Hospital, Aurangabad on 21.10.2022. Accordingly, the applicant underwent medical check-up. Thereafter, the respondent No. 3 forwarded the impugned letter dated 16.2.2023 (Annexure A-6) to the respondent No. 2 at Nagpur for guidance in respect of the applicant's partial blindness and opinion whether the applicant can be continued in service compulsorily retired. It is the contention of the applicant that his apprehension depriving his job contrary to the provision of Section 20(4) of the Rights of Persons with Disabilities Act, 2016. His salary is also being withheld illegally. Hence, the applicant seeks interim relief.

7. Upon perusal of the impugned letter dated 16.02.2023 (Annexure A-6), it is evident that the apprehension of coercive action in respect of the applicant is imminent and reasonable. Perusal of the document nomenclatured as P.F./COM PEN/LEAVE (page No. 38 of paper book) issued by the Medical Board, J.J. Hospital Mumbai would show that there is reference to certificate issued by the Aurangabad Medical Board mentioning as follows:-

"partial optic atrophy"

which can be stated as partial disability in vision.

8. Section 20(4) of the Rights of Persons with Disabilities Act, 2016 is as follows:-

"20. (4) No Government establishment shall dispense with or reduce in rank, an employee who acquires a disability during his or her service:

Provided that, if an employee after acquiring disability is not suitable for the post he was holding, shall be shifted to some other post with the same pay scale and service benefits:

Provided further that if it is not possible to adjust the employee against any post, he may be kept on a supernumerary post until a suitable post is available or he attains the age of superannuation, whichever is earlier."

9. As per first proviso to Section 20(4) of the Rights of Persons with Disabilities Act, 2016, provides that, if an employee after acquiring disability is not suitable for the post he was holding, shall be shifted to some other post with the same pay scale and service benefits. This provision is mandatory in nature. In view of the same, the guidance sought by the respondent No. 3 by it's letter dated 16.02.2016 from respondent No. 2 definitely is in contravention of the above-said provisions of the Disabilities Act. In view of the same, the applicant's apprehension of compulsory retirement of his services is well founded. Hence, this is a fit case to protect the applicant from coercive action as expressed in impugned

letter dated 16.02.2023 (Annexure A-6). In view of the same, interim relief is granted in following terms:-

"Pending hearing and final disposal of the original application, no coercive action until further order shall be taken by the respondents against the applicant."

So far as further interim relief in terms of arrears of salary from June 2022 on wards is concerned, the respondents are directed to take necessary steps to redress the said grievance in accordance with law.

- 10. Issue notices to the respondents, returnable on 12.06.2023.
- 11. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- 12. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- 13. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure)

Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
