4. On careful perusal of the minutes of meeting of the Civil Services Board which at page No. 54 (Annex. 'R-1') dated 28.06.2023 and on careful

perusal of chart annexed to the said minutes of meeting wherein the names of the employees who have completed 3 years and more at the end of 31.05.2023 found to be considered. At Sr. No. 15 the name of the applicant is mentioned. Even though five places of her choice were vacant at the time of recommendation made by the C.S.B., the applicant was given the posting at some different place for which she has not exercised the option.

5. On perusal of the said chart particularly under the said category, it also appears that for most of the employees, the choice of their place has been considered. There is no explanation about this discrimination expect the administrative exigency.

6. By order dated 15.03.2024, when the learned counsel for the applicant has pointed out that the applicant has submitted the representation dated 20.02.2024 to the District Collector, Ahmednagar stating therein that the posts in terms of the options exercised as of Circle Officer, Belvandi, Tq. Shrigonda, Dist. Ahmednagar and Circle Officer, Nalegaon, Tq. and Dist. Ahmednagar are still vacant and as such, the applicant may be considered on

either of the said post and this Original Application can be disposed of if her representation considered favorably.

December, 2018 and in the circumstances his experience was noticed to be less than one year. It is the case of the applicant that he has passed M.D. examination on 11.07.2018 and the date 3<sup>rd</sup> December, 2018 is the date of issuance of certificate of M.D. in favour of the applicant. As is revealing from the experience certificate placed on record by the applicant, the Principal of Government Medical College, Thrissur, has certified that the applicant has completed one year Senior Residency from 11.07.2018 till 08.08.2019. This period is more than the period of one year. Having regard to the fact as above, it appears to us that the applicant also deserves to be considered for his selection. Similar matters have been decided by this Tribunal by order dated 29.02.2024. However, since few facts are distinguishable, this matter was not clubbed with said group of matters. However, same relief deserves to be granted to the present applicant also. We, therefore, inclined to pass the following order: -

**ORDER**

- (i) It is held that the applicant holds requisite experience as prescribed in the advertisement.

(ii) Consequently, the decision of the MPSC declaring the present applicant ineligible on the count of experience is quashed and set aside.

(iii) The MPSC is directed to consider the name of the present applicant also while recommending the names of eligible candidates for to be appointed on the subject post.

(iv) The aforesaid exercise shall be carried out within a period of 06 weeks from the date of this order.

(v) The Original Application stands allowed in the aforesaid terms, however, without any order as to costs.

2. The present applicant was not considered for his promotion on the ground that the criminal prosecution was pending against him. In the DPC meeting held on 28.12.2023 the recommendations of the applicant are kept in sealed cover. Now it is the contention of the applicant that his name has been deleted from the array of the accused in the criminal case, which was allegedly pending against him and, as such, there is no case at present pending against him. In the circumstances, the applicant has approached this Tribunal seeking direction against the respondents to consider his case as provided under clause 12 of the Government Resolution dated 15.12.2017.

3. Learned Presenting Officer though did not raise any dispute to pass any order in the present matter, submitted that the day applicant submitted

representation with the Collector, Beed, on the same day he has filed the present Original Application. Learned P.O. submits that he must have waited for some time for the decision of the Collector.

4. Though the contention of the learned P.O. cannot be out rightly rejected, it appears to us that the Government employees prefer to approach Tribunal as early as possible for the reason that unless there is an order from the Tribunal no decision is taken. We do not want to comment on this issue. The present O.A. can be disposed of by giving directions to the respondents to consider the case of the present applicant for his promotion in view of deletion of his name from the criminal prosecution against him. Ordered accordingly.

(ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(iii) Applicant are authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
