- 2. Applicant has challenged the Summary Dismissal order dated 18.04.2018 passed by the Respondent No.3 thereby invoking the powers under Article 311(2)(b) proviso of the Constitution of India.
- 3. During the course of arguments learned C.P.O. has pointed out that the applicant has preferred appeal dated 02.05.2018 before Respondent No.1 against the impugned order of dismissal dated 18.04.2018. Under such circumstances the Applicant cannot prosecute before two fora as O.A. was filed on 23.04.2019. It is pointed out that Appeal was preferred earlier i.e. before filing of the present O.A. However, when the Appeal was pending Applicant should not have filed the O.A.
- 4. Learned Counsel has pointed that at page 20, Applicant has submitted that copy of Appeal. He has pointed out that at paragraph 6.6 of the averments Applicant has mentioned that,

"6.6 On 02.05.2018 the Applicant submitted appeal cum representation before Respondent No.1 against the order of dismissal dated 18.04.2018."

5. However, it is found that Applicant has made two contrary statements. Though at paragraph 6.6 in the averments he mentioned that the pending appeal, however, at paragraph 9 it is stated as below:

"The Applicant has not filed any other appeal or application in any other Court except this Honorable Maharashtra Administrative Tribunal, Mumbai."

- 6. Learned Counsel on instructions has submitted that he would like to withdraw this O.A. as appeal is pending and the Applicant is pursuing the appeal.
- 7. In view of above, we pass the following order:

- 2. The applicant challenges the order dated 2.3.2018 issued by respondent no.3 of his reversion from the post of PSI to ASI. Earlier the applicant was promoted to the post of PSI on 22.9.2017.
- 3. Ld. PO submits that during pendency of OA the applicant was promoted to the post of PSI on 20.10.2020. Applicant retired on 23.7.2021. Therefore nothing remains in the OA and the same may be disposed off.
- 4. Ld. Advocate for the applicant confirms these two facts. However, he submits that order of reversion was passed on 2.3.2018 and thereafter he filed OA on 20.4.2018. Ld. Advocate for the applicant submits that he has prayed for other consequential service benefits and therefore he is entitled to get the deemed date of promotion of PSI since 22.9.2017.
- 5. We make it clear that no application for amendment praying for deemed date is moved by the applicant after he got the promotion. Deemed date cannot be granted under the general relief praying for consequential service benefits. There should be specific prayer and no amendment is carried out.
- 6. Ld. Advocate for the applicant submits that applicant will make a representation for grant of deemed date of promotion to the post of PSI to the DGP.
- 7. In view of the above since the applicant is already promoted on 20.10.2020, nothing remains in the OA and the same is disposed off accordingly,.
