Government of NCT of Delhi and Ors. [O.A. No. 2039/2005)** decided on 7.10.2005, submitted that only for the reason that the criminal prosecution is pending against the applicant he cannot be denied an appointment when he has successfully undergone the selection process. Learned counsel, in the circumstances, prayed for staying the effect and operation of the impugned order till decision of the present O.A.
