Punam Mahajan, learned Advocate for Applicant through 'Video Conference' and Shri A.J. Chougule, learned Presenting Officer for Respondents.</p> <p>2. Learned Advocate for Applicant states that 'Suspension Order' dated 24.02.2024 has been revoked by 'Spl IGP, Kolhapur Range; Kolhapur' on 01.06.2024.</p> <p>3. Learned Advocate for Applicant then states that principal grievance of Applicant about 'Suspension Order' dated 24.02.2024 passed by 'Spl IGP, Kolhapur Range; Kolhapur' now stands redressed, however based on principles of parity with Applicants in O.A. No. 205/2024 & Ors. who were not only reinstated but to posts they had held earlier viz. (a) 'SDO Purandar' (b) 'Tahsildar Saswad' & (C) 'SDPO Bhor' by Judgment dated 02.04.2024; of 'MAT-Aurangabad Bench' the Applicant should have been also been posted back by 'SP (Rural) Pune' to his ealier post of 'Police Inspector, Saswad Police Station'.</p> <p>4. Learned PO produces copy of Order dated 01.06.2024 of 'Spl IGP, Kolhapur Range; Kolhapur' regarding revocation of 'Suspension Order' dated 24.02.2024 of Applicant as per directions given in 'Para 8' and 'Para 9' of Order dated 23.05.2024 alongwith copy of letter of 'SP (Rural) Pune' dated 06.06.2024.</p>

5. Learned PO then drew attention to Order dated 03.06.2024 of 'SP (Rural) Pune' by which Applicant upon reinstatement on 01.06.2024 has been made to join in 'Control Room' on temporary basis with assignment of 'Bandobast Duty'.

6. Learned Advocate for Applicant thereupon states that as remaining prayer of Applicant now stands limited to being posted back on earlier post of 'Police Inspector, Saswad Police Station, Pune'; therefore with liberty to file new O.A. Applicant wants to withdraw O.A. No. 664/2024.

7. The Applicant is accordingly permitted to withdraw O.A. No. 664/2024. Consequently; O.A. No. 664/2024 stands disposed off. No Order as to Cost.
