- 3. After receipt of the impugned order dated 25.10.2021, the applicant made representation dated 26.10.2021 (Annex. 'A-5') to the Hon'ble Minister of Rural Development & Panchayati Raj department, Maharashtra State, Mumbai. He also sent E-mail (Annex. 'A-6') to the respondent No.3 i.e. the Chief Executive Officer, Zilla Parishad, Dhule seeking cancellation of the impugned transfer or else he would proceed on indefinite fast.
- 4. Notices were already issued to the respondents as per first order passed in the Original Application on 03.12.2021. At that time, the interim relief order was passed directing the respondent No.1 to consider and decide the representation dated 26.10.2021 (Annex. 'A-5'), made by the applicant to the Hon'ble Minister of the concerned department. However, point of interim relief was kept open. Thereafter, the hearing of the Original Application was adjourned from time to time on 13.12.2021, 17.12.2021, 05.01.2022 and on 06.01.2022.
- 5. Meanwhile, the affidavit-in-reply on behalf of respondent No.3 only is filed on 17.12.2021. However,

in spite of grant of time, the affidavit-in-reply on behalf of the respondent Nos.1 and 2 is not yet filed. Meanwhile, representation dated 26.10.2021 (Annex. 'A-5') is decided by the respondent No.1 thereby rejecting the same.

- 6. Learned Advocate for the applicant submitted that though sufficient time is granted and the matter is adjourned from time to time, no affidavit-in-reply is yet filed on behalf of the respondent Nos.1 and 2. Therefore, he has argued the matter in respect of interim relief of stay as prayed for in the paragraph No.12 (E).
- 7. It is the contention of the applicant that the impugned order passed by the respondent No.3 is without jurisdiction and also in contravention of the necessary directions issued by the authorities of Divisional Commissioner, Nashik vide circular dated 01.09.2020 (Annex. 'A-9').
- 8. In that regard, the learned Advocate for the applicant submitted that similar order was passed by the respondent No.3 relieving one Smt. Nisha

Prabhakar Jadhav ex-parte w.e.f. 04.09.2020 after office hours by order dated 04.09.2020. The respondent No.1 as per the communication dated 06.10.2020 addressed to Divisional Commissioner, Nashik opined that the jurisdiction of transfer of the officers in the cadre of Assistant Block Development, Group 'B' is vested in the Government and order of transfer of Smt. Nisha Prabhakar Jadhav was issued without seeking requisite sanction of the Government.

- 9. Learned Advocate for the applicant further invited my attention to the copy of order dated 22.11.2021 (page no.44 b of the P.B.) whereby the Government has set aside the similar order dated 22.11.2021 relieving one Shri N.K. Patil, Deputy Commissioner, Municipal Corporation, Solapur was cancelled as it was not in accordance with Rules.
- 10. Learned Advocate for the applicant further invited my attention to the decision of Maharashtra Administrative Tribunal, Mumbai in <u>O.A.No.928/2018</u> in the matter of Shri Kiran Anant Lohar Vs. The Chief Executive Officer, Zilla Parishad, Kolhapur

dated 19.06.2019 whereby similar order of relieving exparte of the Education Officer (Secondary), Zilla Parishad Kolhapur issued by Chief Executive Officer, S.P., Kolhapur was quashed and set aside holding that the said relieving order is having the effect of transfer and the midterm and mid-tenure order cannot be passed in contravention of Section 4 (4)(ii) and 4(5) of Transfer Act, 2005.

- 11. As against that, in the affidavit-in-reply filed on behalf of the respondent, it is contended that the impugned order of relieving the applicant ex-parte on 25.10.2021 is passed well within the power vested in the respondent No.3. It is specifically contended that while working on the said post, behavior of the applicant was such that he has caused mental harassment to the officers in the establishment and in spite of directions given to the applicant there was no improvement in his behavior. Subordinate staff members have made complaint against the applicant.
- 12. In view of same, show cause notice dated 20.10.2021 was issued to the applicant to which the applicant filed reply dated 22.10.2021 and thereafter,

the impugned order dated 25.10.2021 came to be passed. The impugned order of relieving is passed in order to have smooth affairs in the office of Zilla Parishad, Dhule. It is in accordance with law.

- 13. Learned C.P.O. appearing on behalf of the respondent Nos.1 and 2 submitted that the Government has taken steps to give the posting to the applicant and in that regard he has placed on record the copy of communication dated 04.01.2022 which is marked as document 'X-1' for the purpose of identification addressed by the respondent No.1 to the respondent No.3.
- 14. Learned Advocate for the respondent No.3 strenuously urged before me that Rule 14 of Maharashtra Civil Services (Discipline and Appeal) Rues, 1979 vests powers in borrowing authority such as the respondent No.3 herein is having all powers of the appointing authority for the purpose of placing such government servant under suspension and of the disciplinary authority for the purpose of conducting a disciplinary proceedings against him. Thereafter he submitted that the impugned order is passed by the

respondent No.3 by invoking powers vested in the said authority as per Rule 14 of M.C.S. (Discipline and Appeal) Rules, 1979 thereof.

- 15. He further submitted that for the misconduct of the applicant, disciplinary action is contemplated and therefore, in order to have the conducive atmosphere in the establishment, the impugned order is passed.
- 16. Considering the rival submissions, it is evident that the question arises as to whether the respondent No.3 is legally empowered to issue impugned order of relieving the applicant.
- 17. Learned Advocate for the applicant has heavily placed reliance on Sub Rule 1 of Rule 14 of M.C.S. (Discipline and Appeal) Rules, 1979 for that purpose. It is read as follows:-
  - "(1) Where the services of a Government servant are lent by one department of Government to another department of Government or to any other Government in India or to an authority subordinate thereto or to a local or other authority (including any company or corporation owned or controlled by Government) (hereinafter in this rule

referred to as "the borrowing authority"), the borrowing authority shall have the powers of the appointing authority for the purpose of placing such Government servant under suspension and of the disciplinary authority for the purpose of conducting a disciplinary proceeding against him.

Provided that, the borrowing authority shall forthwith inform the authority which lent the services of the Government servant (hereinafter in this rule referred to as "the lending authority) of the circumstances leading to the order of suspension of such Government servant or the commencement of the disciplinary proceeding, as the case may be."

- 18. Plain reading of above said provision shows that the borrowing authority has power of suspension and conducting a disciplinary proceeding against the Government servant. It does not speak of any other power and more specifically power of transfer of the borrowed government servant.
- 19. In this regard, useful reference can be made to circular dated 01.09.2020 (Annex. 'A-9') issued by the Divisional Commissioner, Nashik wherein it is directed

that borrowing authority not to relive such officer exparte under any circumstances and such authority can issue show cause notice, memo, charge sheet for disciplinary action and shall inform the Government regarding transfer of such officer.

- 20. Learned Advocate for the applicant has demonstrated that similar order passed by the respondent No.3 was not appreciated the Government favorably and it was stated that the right of transfer of the officer in Group 'B' and Group 'A' vested in the Government and not in authority. One such similar nature order passed by the authority of Municipal Corporation, Solapur was cancelled by the Government, which is referred at page no.44 B of the Paper Book. The Co-ordinate bench of this Tribunal has been pleased to quash and set aside the such order observing that the said order is in contravention of the provisions of Section 4 (4) (ii) and 4(5) of Transfer Act, 2005 and it can be governed by Transfer Act, 2005.
- 21. In the circumstances as above, in my considered opinion, prima-facie it is evident that the impugned order of relieving the applicant dated 25.10.2021 is not

sustainable and therefore, the same is required to be stayed and to restore the status quo ante as prayed for. I therefore, proceed to pass following order:-

#### ORDER

Interim relief in terms of prayer clause 12(E) as follows is granted:-

"Pending the admission, hearing and final disposal of this original application the effect of impugned order dated 25/10/2021 (Annex. A-4) issued by the Resp. No.3 may kindly be stayed and the Resp. No.3 may kindly be directed to permit the applicant to discharge duties attached to his post of Deputy Chief Executive Officer (Water Supply & Sanitization) Zilla Praishad, Dhule."
