Learned counsel for the applicant submits that the applicant was keeping physically and mentally unwell and therefore, he could not file the Original Application within time. Learned counsel for the applicant has submitted that it is a case of dismissal after putting more than 30 years of service and hence the delay may be condoned.</p> <p>4. Learned C.P.O opposes condonation of delay in filing the Original Application.</p> <p>5. We find that the Original Application is filed on 15.12.2022. It should have been filed on 31.12.2022. However, on account of Covid-19 Pandemic and in view of the order dated 23.9.2021 of the Hon'ble Supreme Court in M.A 665/2021 in SMW (C) No. 3/2020, the period from March, 2020 till February, 2022 is to be excluded for the purpose of limitation. Thus, there is a delay of nearly 10 months in filing the Original Application.</p> <p>6. In view of the submissions of the learned counsel for the applicant and in order to give one opportunity to the applicant, we condone the delay by imposing cost of Rs. 500/- which should be deposited in the Registry of the Maharashtra Administrative Tribunal.</p> <p>7.
