However, the applicant has been transferred at Paithan Open Prison. Learned counsel submitted that some posts are still vacant at Dhule District Prison, as well as, at Nashik. It is further contended that the applicant intends to prefer representation with the respondent authorities to consider his case for his posting at Dhule

or at Nashik on any of the said vacant posts. Learned counsel submitted that since the Original Application is pending, unless it is permitted by the Tribunal, the applicant may not be able to file such representation and the respondents also will not consider the said representation unless permitted by this Tribunal.

4. In view of the submissions made on behalf of the applicant, the applicant is permitted to file such representation with the respondent authorities and if such representation is filed by the applicant the respondent authorities may consider the same on its own merits.
