2. Ld. PO states that order is fully complied with and payment of arrears of Rs.6,97,887/- is deposited in applicant's account.

3. It is seen that judgment of this Tribunal in the above OA No.313 of 2015 was rendered on 5.10.2015. Said judgment was carried before Hon'ble High Court. Hon'ble High Court dismissed the writ petition filed by State by judgment and order dated 22.2.2016. While dismissing the writ petition filed by the State, Hon'ble High Court extended the period which was prescribed by this Tribunal for compliance, by four weeks, as is seen from para 15 of the order of the Hon'ble High Court.

However, this compliance is delayed by over seven months. This belated compliance does not in any manner exonerate the contemnor from their act o omission amounting to willful disobedience of the order.

- (b) The date when he came to know about pendency of present contempt application.
- (c) Names of officers who have contributed to and are responsible for the delay in compliance of the order, after completing any enquiry, if necessary, within six weeks from today along with exact lapse attributable to each officer concerned.
- (d) What steps he would take for compliance of the order at the level of the Government whenever compliance is required to be done by the Government and/or other officer and the manner in which he would channelize handling of the case in order to punctually comply the order.
