  - "A) This Original Application may kindly be allowed thereby quashing & setting aside the five Departmental Enquiries initiated against applicant by Resp. Nos. 1 and 2 vide impugned Memorandums of Charge dated 14/03/2024, 13/03/2024, 07/03/2024, 12/03/2024 and 06/03/2024 (Annexs. A-1 Colly. to A-5 Colly.).
  - B) Costs of this Original Application may kindly be awarded to the applicant.
  - C) Any other appropriate relief as may be deemed fit by this Hon'ble Tribunal may kindly be granted.

#### **INTERIM RELIEF**

D) Pending the admission, hearing and final disposal of this Original Application

Respondents may kindly be restrained from proceeding ahead in any manner in the five Departmental Enquiries initiated against applicant vide impugned Memorandums of Charge dated 14/03/2024, 13/03/2024, 07/03/2024, 12/03/2024 and 06/03/2024 (Annexs. A-1 Colly. to A-5 Colly.).

- E) Pending the admission, hearing and final disposal of this Original Application all further proceedings in the five Departmental Enquiries initiated against applicant vide impugned Memorandums of Charge dated 14/03/2024, 13/03/2024, 07/03/2024, 12/03/2024 and 06/03/2024 (Annexs. A-1 Colly. to A-5 Colly.) may kindly be stayed.
- F) Ad-interim relief in terms of Prayer Clauses "D" and "E" hereinabove may kindly be granted in favour of the applicant."
- 3. Learned Counsel appearing for the applicant submitted that all these enquiries are initiated with oblique motive and with the only object of denying the promotion to the present applicant to the post of Chief Engineer. Learned Counsel submitted that, the applicant has raised specific allegations against respondent no.4 alleging that at his instance all these actions have been initiated against the applicant.

- 4. Learned Counsel submitted that, previously also the applicant was required to approach this Tribunal and the O.A. filed by the applicant is still pending before this Tribunal. Learned Counsel pointed out that in the said O.A. Tribunal has passed interim order thereby protecting the interest of the applicant giving directions to the respondents to consider the applicant for promotion of Chief Engineer. Learned Counsel submitted that after passing the said order by this Tribunal hurriedly in few days five enquiries have been initiated against the applicant. Learned Counsel submits that the very intention of the respondents is to keep the applicant away from the post of Chief Engineer.
- 5. Learned Counsel invited our attention to G.R. dated 08-06-2020, more particularly, clause 1.5 thereof. Learned Counsel submitted that the matters which could not have been handled or looked into by respondent no.4 have been indulged by the said respondent his and on further actions recommendations have been initiated against the applicant. Learned Counsel submitted that the enquiries which are initiated with oblique motive and mala fide intention can

certainly be challenged before this Tribunal and sought to be quashed even at the initial stage.

- 6. Shri V.R.Bhumkar, learned P.O. appearing for the State authorities opposed for grant of any such interim relief. Learned P.O. submitted that it was open for the applicant to submit his reply to all the said statements of charges served upon him making out a case showing his innocence. Learned P.O. submitted that without availing the said opportunity applicant has approached this Tribunal. Learned P.O. submitted that to conduct an enquiry into misconduct alleged against the Government employee within the right and authority of the State. Learned P.O. further submitted that, whatever has been argued by the learned Counsel for the applicant that may be the defense of the applicant in the enquiry proceedings but it cannot be considered at this stage. He has, therefore, prayed for rejecting the request for grant of any interim relief.
- 7. We have considered the submissions made on behalf of the applicant as well as the State authorities. We have gone through the documents placed on record as well as the earlier order passed

by this Tribunal in O.A.No.117/2024. The statements of charge which are served on the applicant and which are subject matter of the present O.A. are also gone into by us.

- 8. After having considered the submissions and after having gone through the documents placed on record, it is difficult at this stage to reach to any conclusion either in favour of the applicant or against him. The averments which are taken and the submissions which are made in the arguments can be a defense of the applicant in the departmental enquiry proceedings in respect of charges leveled against him. It cannot be disputed that the State has a right and authority to hold enquiry into misconduct alleged against its employees. In the circumstances, it is difficult to accept the request of the applicant to restrain the respondents from proceedings with the enquiries at this stage.
- 9. For the reasons stated above, we deem it appropriate to pass the following order:

- [i] Issue notice to respondents, returnable on 10-06-2024. Respondents to show cause why the request of applicant for staying all the enquiry proceedings pending against him shall not be accepted.
- [ii] Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- [iii] Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- [iv] This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- [v] The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
- [vi] S.O. to 10-06-2024.
- [vii] Steno copy and Hamdast is allowed to both parties.

Learned counsel for the applicant submits that by communication dated 29.04.2019 the respondent No. 5 has submitted proposal to respondent No. 4 about grant of benefits of revised ACPS in terms of the application submitted by the applicant. However, the said proposal is still under consideration and it is not yet decided. Learned counsel submits that

there is a recurring cause of action, since the said proposal is yet not considered and decided by the respondent authorities.

5. Learned counsel submits that further due to outbreak of COVID-19, the Hon'ble Supreme Court in March, 2020 took Suo-Motu cognizance of the difficulties that might be faced by the litigants in filing petitions/ applications/suits/appeals/ other quasi proceedings within the period of limitation prescribed under the general law of limitation. Learned counsel has pointed out from the order about cognizance of the limitation passed by the Hon'ble Supreme Court in M.A. 665/2021 in Suo Motu Writ Petition No. 3/2020, wherein the period from 15.03.2020 till 28.02.2022 and even prior to that has been excluded in computing the periods under Sections 23(4) and 29A of the Arbitration and Conciliation Act, 1996, Section 12A of the Commercial Courts Act, 2015 and provisos (b) and (c) of Section 138 of the Negotiable Instruments Act, 1881 and any other laws, which prescribe period(s) of limitation for instituting proceedings, outer limits

within which the court or Tribunal can condone delay.

- 6. Learned counsel for the applicant submits that there is no inaction on part of the applicant nor there is a deliberate or intentional delay in filing the accompanying Original Application. The applicant has been prevented from sufficient cause to prefer the Original Application within limitation and otherwise there is a recurring cause of action and as such, the issue of limitation as raised by the office is merely technical objection.
- 7. Learned Presenting Officer submits that there is an inordinate delay caused in filing the accompanying Original Application and the delay has not been explained satisfactorily. There is no substance in the present Misc. Application seeking condonation of delay and the same is liable to be dismissed.
- 8. It appears that though the applicant has submitted representation on 04.04.2019 to extend the benefit of revised ACPS and even the respondent

No. 5 has submitted proposal to respondent No. 4 along with positive recommendations by way of communication dated 29.04.2019, the said proposal is still pending. In view of the same, I find much substance in the submissions made on behalf of the applicant that there is a recurring cause of action since the said proposal is yet not decided. Apart from that, in view of the order passed by the Hon'ble Supreme Court in the backdrop of the COVID-19 pandemic, the said period after submission of representation by the applicant and the proposal forwarded by the respondent No. 5 to respondent No. 4 is liable to be excluded. In view the same, I am inclined to condone the delay caused in filing the accompanying Original Application, subject to payment of costs by the applicant. Hence, the following order:-

- (ii) The delay of 01 year, 09 months and 08 days caused in filing the accompanying O.A. under

- 2. The present applicants had applied for the post of Live Stock Development Officer, Group-A and after having undergone the selection process their names are included in the waiting list prepared by the Maharashtra Public Service Commission (for short 'the Commission).
- 3. It is the case of the applicants that after the advertisement was issued for inviting applications from the eligible candidates for filling the post of Live Stock Development Officer, another advertisement was issued inviting applications from the eligible candidates for filling post of Assistant the Commissioner, Animal Husbandry. The post of Assistant Commissioner, Animal Husbandry is a promotional post.

- 4. It is the further contention of the applicants that 04 candidates who had applied for the post of Live Stock Development Officer and who were duly selected for the said post had also applied for the post of Assistant Commissioner, Animal Husbandry and they have been selected for the said post also. Learned counsel submitted that the said 04 candidates had joined the post of Live Stock Development Officer and were also sent for training. However, after they were selected for the post of Assistant Commissioner they requested the State authorities to permit them to join the post of Commissioner Assistant by accepting resignation of the post of Live Stock Development Officer and their request has been considered positively and on submitting resignation for the post of Live Stock Development Officer they are allowed to join the post of Assistant Commissioner, Animal Husbandry and in fact all these officers have joined the said post.
- 5. Learned counsel further submitted that as because said 04 candidates joined promotional post,

earlier posts occupied by them of Live Stock Development Officer have fallen vacant. Learned counsel further submitted that for different reasons other 07 candidates did not join and the said posts also had fallen vacant. Learned counsel further submitted that 04 candidates who did not join and 04 candidates who are before this Tribunal are from the same reserved class and in order of merit the applicants are next to the said candidates who were selected and joined the post of Live Stock Development Officer. Learned counsel further submitted that after acceptance of the resignation of 04 candidates, said applicants, being meritorious candidates in the said respective categories the applicants have prayed for sending requisition to the Commission recommending their name and in turn to give appointment to them on the said post.

6. Learned counsel submitted that since no positive indications were seen from the side of the respondents, the applicants have approached this Tribunal. Learned counsel submitted that the applicants have made out a prima facie case for their

appointment on the posts which are fallen vacant, however, if the Government undertakes fresh recruitment process, the applicants will be deprived from getting appointment though their names are included in the waiting list.

- 7. Learned Chief Presenting Officer seeks time to take instructions from the respondents. Learned C.P.O., however, has tendered one communication dated 12.04.2024 which is requisition made to the Commission by the respondents for sending recommendation for 07 candidates named in the waiting list to be given appointments against the seats remained unfilled because of non-joining of said candidates. Learned C.P.O. submitted that the same procedure is likely to be followed in respect of 04 posts, which are fallen vacant. In the circumstances, according to learned C.P.O., the applicants have hurriedly approached this Tribunal without waiting response of the respondents.
- 8. After having considered the submissions made on behalf of the applicants and the learned C.P.O., prima facie, it appears that the applicants have made out a case for their recommendation to fill in

the posts which have remained vacant since applicants are the next candidates in order of merits in the respective categories.

- 9. From the submissions made by the learned Chief Presenting Officer and the documents placed on record by him it is revealed that to fill in 07 posts which have remained unfilled as because the candidates selected for the said post did not join, the State Government has sent requisition to the Commission to recommend the names of next 07 candidates whose names are existing in the waiting It is not explained by the respondents why along with the requisition for 07 candidates, requisition for filling 04 posts remained unfilled because of the candidates selected against the said seats have resigned is not forwarded. Learned C.P.O. also could not make any statement in this regard.
- 10. Having regard to the apprehension expressed by the applicants that the respondents may instead of filling the said 04 post from the wait listed candidates go for the fresh recruitment process, we deem it appropriate to pass the following order: -

#### ORDER

- (i) Issue notice to the respondents, returnable on 18.06.2024. The respondents shall explain what steps are being taken for filling 04 posts, which have fallen vacant because of resignation of the selected candidates. Till then the respondents shall not take any further step for filling the said 04 posts.
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (iii) Applicants are authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- (iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

Learned Senior counsel submitted that vide the said notification the Assistant Teachers are excluded from applying for the Limited Departmental Competitive Examination conducted bv the Maharashtra Public Service Commission (for short 'the Commission') to get the regular promotion to the post of Deputy Education Officer. Learned Senior counsel submitted that as per the rules of 2016 the Assistant Teachers were eligible for promotion to the post of Deputy Education Officer. Learned Senior counsel submitted that after having considered the grievance raised by the applicants this Tribunal has passed an interim order on

16.03.2023 and thereby has the restrained respondents from carrying out further promotions till filing of affidavit in reply by them. Senior counsel further submitted that while passing the order on 28.02.2024 the aforesaid facts were not correctly brought to the notice of the Tribunal and the interim order passed on 16.03.2023 was got modified.
