- 2. The O.A. is made challenging the impugned transfer order dated 30-05-2023 to the extent of applicant issued by the respondent no.1 thereby transferring the applicant from Government Polytechnic, Jintur to Government Polytechnic, Ratnagiri.
- 3. Applicant came to be appointed as a Lecturer (Instrumentation Engineering) in the cadre of Maharashtra Polytechnic Services (Group-A) and was posted at Government Polytechnic, Jintur by order dated 20-12-2010 (Annexure A-1). Due to shortfall of workload in Government Polytechnic, Jintur in March, 2020 applicant was asked to work on deputation at Government Polytechnic, Nanded in the branch of Medical Electronics. Applicant worked there till he was relieved just before the impugned transfer order dated 30-05-2023 (Annexure A-3).

By the said impugned transfer order applicant is being transferred to Government Polytechnic, Ratnagiri on the post of Lecturer in Electronics Engineering Department stating that it is equivalent post. According to the applicant it is not an equivalent post in terms of G.R. dated 18-10-2016 (Annexure A-4) issued by respondent no.1. According to the applicant Subject of Electronics Engineering is not studied by him and therefore he cannot teach the said subject of Electronics Engineering.

- 4. Learned Advocate for the applicant submits that absorption of an employee due to being surplus is governed by G.R. dated 10-09-2001 (Annexure A-9 collectively). The impugned order is issued in contravention of the said G.R. dated 10-09-2001. Hence, learned Advocate for the applicant seeks interim relief of stay to the execution and implementation of the impugned order so far as the applicant is concerned.
- 5. Learned P.O. opposed the submissions made on behalf of the applicant and sought time for filing affidavit in reply and more particularly to seek

instructions as to whether the posting given to the applicant on transfer is equivalent to the post held by him.

6. Considering the above situation, point to be elaborated by the respondents whether the transfer posting given to the applicant as a Lecturer in Electronics Engineering is equivalent post to the post on which he was initially appointed as a Lecturer for subject of Instrumentation Engineering or not. Prima facie in G.R. dated 18-10-2016 (Annexure A-4) Electronics Engineering is not shown that Instrumentation equivalent to of as Moreover, G.R. dated 10-09-2001 Engineering. which is part of Annexure A-9, particularly clause 5.2 of the said G.R. reads thus:

#### "५. अतिरिक्त संवर्ग कक्ष

५.२ अतिरिक्त ठरलेल्या (योजनांतर्गत/योजनेतर) पदांपैकी ज्या पदावर कर्मचारी कार्यरत आहेत अशा कर्मचा—यांनी धारण केलेली पदे सुध्दा रद्द करण्यात यावीत. तथापि त्यांच्या वेतनाची व्यवस्था व्हावी या दृष्टीने त्यांचेसाठी त्यांना अतिरिक्त ठरविल्याच्या दिनांकापासून इतर पदावर सामावून घेईपर्यंतच्या कालावधीसाठी अधिसंख्य पदे निर्माण करण्याचा प्रस्ताव वित्त विभागाकडे सादर करावा. अतिरिक्त ठरलेल्या कर्मचा—यांसाठी अधिसंख्य पदे निर्माण करण्याच्या प्रस्तावास उच्चस्तरीय सचिव समितीच्या मान्यतेची आवश्यकता राहणार नाही. अतिरिक्त ठरलेल्या अधिकारी/कर्मचारी यांना समकक्ष पदावर सामावून घेईपर्यंत ते त्यांच्या मूळ विभागात/कार्यालयात राहतील आणि

त्यांचे वेतन व भत्ते त्या कार्यालयाच्या लेखा शीर्षाखाली त्याच कार्यालयाकडुन काढले जातील."

- 7. In view of above, the situation is likely to be arisen that in case of joining the posting by the applicant at the transferred place, the applicant would not be able to teach the subject of Electronic Engineering. In view thereof, in my opinion this is a fit case to grant interim relief till filing of reply in terms of prayer clause 8(i). Interim relief is granted in terms of prayer clause 8(i) till filing of reply. Prayer clause 8(i) is as follows:
  - "8) i). The impugned order Outward No. Badli 323/PK44.23/TS-7 dated 30.05.2023 issued by Karyasan Adhikari, Government of Maharashtra transferring the applicant from government polytechnic Jintur to government polytechnic Ratnagiri may kindly be stayed."
