- 2. It is the grievance of the applicant that though he got retired on 30-09-2019 on attaining the age of superannuation, till today, his pension papers are not forwarded to the A.G. Office for grant of regular pension. It is his further grievance that, he has not yet received amount of gratuity as well as the benefit of commutation of pension as well as leave encashment. The applicant has, therefore, approached this Tribunal with the following prayers:
 - "A) The Hon'ble Tribunal may kindly be pleased to allow the Original Application.
 - B) The Hon'ble Tribunal may kindly be pleased to direct the Respondent No.1 to 4 to forward, process and grant the pensionary benefits alongwith the interest for delayed pension to the Original Applicant forthwith alongwith all the consequential benefits from the date of

Superannuation of the Original Applicant in the interest of justice.

- C) Any other equitable and suitable relief may kindly be granted in favour of the Original Applicant in the interest of justice."
- 3. In the affidavit in reply filed on behalf of the respondents, the contention has been raised that in the audit conducted of the relevant period some financial irregularities were noticed to which according to the respondents, the applicant was responsible. In the circumstances, regular pension as well as the amount of gratuity, leave encashment, commutation of pension etc. are withheld by the respondents. From the averments in the affidavit in reply, it is further revealed that an enquiry was conducted and its report was also submitted; but disciplinary authority was not satisfied with the said report and therefore the respondents decided to conduct a fresh enquiry. This appears to be the only ground for not releasing the aforesaid amounts which the applicant has claimed in the present O.A.
- 4. When the matter was heard, pointed queries were made by the Tribunal to the learned P.O. as to whether any statement of charge has been issued till

date to the applicant and whether any departmental enquiry has been initiated or any other effective steps are taken for proceeding with the said enquiry. Learned P.O. on instructions received from Dr. A.S.Ingole, Administrative Officer, who is present before the Tribunal submitted that, till today, no steps have been taken to proceed with the enquiry as has been indicated in the affidavit in reply as well as the reply given to the representation made by the applicant on 18-07-2020. In view of the fact that though period of more than two and half years has lapsed, no steps are taken by the respondents, applicant has become entitled for the regular pension as well as for the admissible financial benefits. It need not be stated that even for conducting the regular enquiry certain time schedule is fixed and respondents are supposed to complete the enquiry within the specified period. In the present matter though more than 3 years have lapsed from the retirement of the applicant, no steps have been taken even to commence the enquiry against the applicant. Merely on the ground that departmental enquiry is contemplated, pensionary benefits payable to the applicant cannot be withheld

for indefinite period. At the most, respondents can obtain undertaking from the applicant that, in case, he is held guilty in the departmental enquiry contemplated against him, he will refund the amounts received by him within the period which may be specified in the said undertaking. In the circumstances, the applicant has certainly made out a case for allowing the present Original Application. Hence, the following order:

ORDER

- [i] Original Application is allowed.
- [ii] By obtaining the necessary undertaking/bond from the applicant, respondents are directed to release the amount of gratuity and other admissible retiral benefits to the applicant and forward the pension papers to A.G. Office for grant of regular pension within 6 weeks from the date of this order.
- [iii] It shall be open for the respondents to conduct departmental enquiry as may be permissible under Rule 27 of the Maharashtra Civil Services (Pension) Rules, 1982.
- [iv] There shall be no order as to costs.

- 2. Since the issues raised in both these Original Applications are identical I have heard both these matters together and I deem it appropriate to pass this common order in both these applications.
- 3. Applicant, Dr. Ajit Prakash Thorbole, in O.A. No. 19/2023 is working as Sub Divisional Officer at Karjat. Dist. Ahmednagar, whereas applicant, Shri Nanasaheb S. Agale, in O.A. No. 20/2023 is working as Tahsildar at Karjat, Dist. Ahmednagar. Applicants have preferred these OAs challenging order dated 30.12.2022 whereby the applicants have

been suspended in contemplation of enquiry to be conducted against both of them. In exception to the impugned order the applicants have raised several grounds. Applicants have also prayed for interim relief thereby seeking stay to the impugned order till decision of the present OAs.

4. While arguing for interim relief the thrust of the learned counsel for the applicants is on the ground that the order so passed is without jurisdiction and without any authority of law. It is contended that both the Officers are assigned some duties and responsibilities in respect of Election of the Legislative Council of Maharashtra more particularly pertaining to the election of Nashik Graduate Constituency. Learned counsel submitted that vide Government order/notification dated 17.9.2021 both the officers are notified for discharging the duties as specified in the said Notification in connection with the aforesaid Learned counsel pointed out that the Election. Election Commissioner of India vide its Notification dated 29.12.2022 has declared the said election. Learned counsel submitted that in view of provisions

U/s 28(A) of the Representation of the People Act, 1951 the applicants in both the OAs are now subjected to the control, superintendence and discipline of the Election Commission. Learned counsel submitted that after issuance of the Notification dated 29.12.2022 no action much less impugned order could not have been passed against the applicants without consultation of the Election Commission. Learned counsel placed reliance on the judgment of the Hon'ble Madhya Pradesh High Court in the case of Santosh Malviya Vs. State of Madhya Pradesh and Another, Writ Petition No. **6944/2019** decided on 11.9.2019. Learned counsel submitted that in the identical set of facts the Hon'ble Madhya Pradesh High Court has set aside the order of suspension passed against the petitioner in the said Writ Petition during existence of the model Code of Conduct.

5. Learned Chief Presenting Officer at the outset has prayed for time for filing detailed affidavit in reply to the contentions raised in the OAs and submitted that unless complete facts come on record it will be unjust to pass even any interim

Learned CPO further submitted that the order. contention of the applicants that the impugned order has been passed after commencement of the model Code of Conduct, is also factually incorrect. Learned CPO submitted that the decision to place the applicants under suspension was in fact taken and declared on 27.12.2022 itself and formal order communicating the said decision has been passed on 30.12.2022. Learned CPO has placed on record the minutes of the discussion held in the Session of Maharashtra Legislative Assembly. Reading out the minutes of the business transacted on 27.12.2022, learned CPO submitted that the decision to suspend the applicants must be held to have taken on 27.12.2022 i.e. prior to commencement of the model Code of Conduct. Reading out the impugned order the learned CPO submitted that in the opening paragraph the facts are appropriately mentioned and in the second paragraph it is further clarified that formal order is passed on 30.12.2022. According to learned CPO, bar of section 28(A) of the Representation of the People Act, 1951 therefore may not be applicable in the present matter.

- 6. Learned counsel for the applicants has also made certain submissions on merits of the matter. It was his contention that no factually correct information was brought on record, though the Collector, Ahmednagar has in his report provided all the relevant particulars explaining the actions initiated by the applicants to combat the illegal activities in respect of stone crushers. Learned counsel submitted that considering the facts as aforesaid even on factual aspects and merits of the said facts the impugned order cannot be sustained. It has also been argued by the learned CPO that accepting the request of the applicants of grant of interim relief as has been prayed by them would amount to granting of final relief, which has been claimed in the OAs. He has therefore prayed for rejecting the request for interim relief.
- 7. I have duly considered the submissions advanced on behalf of the applicants, as well as, on behalf of the respondent authorities. I have also gone through the documents placed on record. As I have earlier noted, several grounds are raised in exception to the impugned order.

- 8. In support of the prayer for interim relief, the learned counsel for the applicants has, however, pressed the only ground which pertains to noncompetence of the State Government to take any action against its officers designated for the conduct of election without consultation of the Election Commission. It is not in dispute that the said period has commenced from 29.12.2022 on which the Election Commission has notified the election of Nashik Graduate Constituency. Two submissions are made on behalf of respondents in oppose to the arguments advanced on behalf of the applicants; first is that the decision was taken prior to commencement of the Code of Conduct period and another that granting of interim relief would amount to grant of final relief.
- 9. It is true that in the session of assembly certain questions were raised by the Members of the Legislative Assembly pertaining to running of stone crushers in the subject area. Minutes which are placed on record reveal that, in the House, the Hon'ble Revenue Minister has assured the Members of the Assembly that action will be taken against all

erring officials and that such Officers will be immediately suspended. It is also true that in the impugned order also there is reference about the assurance so given by the Hon'ble Minister on Floor of Assembly. The fact, however, remains that the impugned order suspending the applicants has been passed on 30.12.2022.

The minutes of the business transacted on 27.12.2022 in legislative assembly reveal that the Hon'ble Revenue Minister assured the Members of the House that the errant Government officials will be suspended, but the order of suspension has been undisputedly passed on 30.12.2022 and must be held to have become operative from the said date and not from any prior date. In the case before the Hon'ble Madhya Pradesh High Court (cited supra) the petitioner therein was placed under suspension vide order dated 14.3.2019. The order of suspension was challenged by the said petitioner mainly on the ground that the said order was passed when the model code of conduct was in force. The said petitioner was assigned with election duties of Lok Sabha election during the relevant period. It was the

argument on behalf of the said petitioner that the order of suspension could have been passed against the said petitioner only after obtaining the permission from the Election Commission. The Hon'ble Madhya Pradesh High Court accepted the argument advanced on behalf of the petitioner and set aside the order of suspension passed against the said petitioner holding that when the order of suspension was passed the State Government has no authority to pass such an order during existence of model code of conduct without permission from the Election Commission. In the instant matter also both the applicants have been assigned with the duties pertaining to election of Nashik Graduate Constituency. The said election has been notified by the Election Commission of India vide its notification dated 29.12.2022. Section 28-A of Representation of the People Act, 1951 provides that returning officer, presiding officer, etc. shall be on deputation to Election Commission. The said section reads as under: -

:: - 9 - :: O.A.NOS. 19 & 20 of 2023

"[28A. Returning officer, presiding officer, etc., deemed to be on deputation to Election Commission. —The returning officer, assistant returning officer, presiding officer, polling officer, and any other officer appointed under this Part, and any police officer designated for the time being by the State Government, for the conduct of any election shall be deemed to be on deputation to the Election Commission for the period commencing on and from the date of the notification calling for such election and ending with the date of declaration of the results of such election and accordingly, such officers shall, during that period, be subject to the control, superintendence and discipline of the Election Commission."

Thus, the applicants who are entrusted with the election duties must be deemed to be on deputation with the Election Commission. Administrative and Disciplinary control over the applicants would be of the Election Commission during the period of code of conduct. If the impugned order is perused it nowhere reveals that before passing the said order the State Government has consulted or had obtained the permission from the Election Commission.

11. For the reasons stated as aforesaid, in my opinion, the applicants have certainly made out a

prima facie case. It prima facie appears that the State Government could not have passed the impugned order without obtaining the permission from the Election Commission. The impugned order thus, appears to have been passed in violation of the provisions under Section 28-A of the Representation of the People Act, 1951. In the circumstances, while issuing notice to the respondents and requiring them to submit their say in regard to the contentions raised in the OAs I deem it appropriate to temporarily stay the effect and operation of the impugned order dated 30.12.2022 till filing of the affidavit in reply by the respondents. Hence, the following order: -

ORDER

- (i) Issue notices to the respondents, returnable on 16.1.2023, till then the impugned order dated 30.12.2022 shall temporarily stand stayed.
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (iii) Applicants are authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete

paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

- 2. Learned counsel for the applicant seeks leave of this Tribunal to correct address of respondent No. 4. Leave granted. Amendment be carried out forthwith.
- 3. Learned counsel for the applicant requested to issue fresh notice to respondent No. 4 on the corrected address.
- 4. After carrying out the amendment, issue fresh notice to respondent No. 4 on the corrected address, returnable on 13.2.2023.
- 5. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- 6. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly

authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

- 7. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- 8. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
