Commissioner of Police on 1.10.2016. He retired on superannuation on 30.4.2017 from the post of Dy. Commissioner of Police. Ld. Advocate submits that two issues are left to be decided. The first is deemed date of promotion of 12.1.2016 to the post of Dy. Commissioner of Police/Superintendent of Police when his colleagues were promoted and second is other consequential pecuniary benefits.
- 3. Ld. Advocate for the applicant submits that he will make representation to concerned authority i.e. respondents no.1 & 2 for appropriate reliefs and the respondents may be directed to decide the said representation within stipulated time.
- 4. Ld. PO submits that if at all such representation is made, three months time will be required to decide the representation from the date of receipt and decision will be communicated within one week thereafter.
- 5. In view of these submissions, the Respondents No.1 & 2 are directed to decide the representation of the applicant, if submitted, within a period of three months from the date of receipt of such representation and communicate the decision to the applicant within one week thereafter. OA disposed off accordingly.
