2. In the present matter main grievance of the applicant is that, the respondents have not taken any decision as about the period of suspension whether to be treated as 'on duty' period or otherwise. Learned Counsel submits that when the applicant has been acquitted from the criminal prosecution against him, respondents are under an obligation to treat the aforesaid period as duty period having considered the provisions in that regard. Other prayers which are made in the application cannot be considered unless the decision is taken in regard to the period of suspension. Learned Counsel for the applicant in the circumstances has not pressed the said prayers. It seems to be the only grievance of the applicant that, after his acquittal from the criminal

prosecution, the respondents must have taken a decision about the period of suspension undergone by him during the pendency of the criminal prosecution against him.

3. From the documents which are there on record, it appears that the respondents have not taken any decision regarding the pay and allowances to be paid to the Government servant for the period of suspension undergone by him and whether or not the said period shall be treated as a period spent on duty. Rule 72 of the Maharashtra Civil Services (Joining Time, Foreign Service and Payment During Suspension, Dismissal and Removal) Rules, 1981 ("Rules of 1981" for short) mandates the Government to consider and make a specific order on the aforesaid aspects.

4. Law is well settled that, it is within the jurisdiction of the competent authority to decide whether suspension was wholly unjustified or otherwise. In the above circumstances, we deem it appropriate to dispose of the present O.A. by directing the respondent no.2 to take a conscious decision considering the entire facts and

circumstances and in light of the provisions under Rule 70 to 72 of the Rules of 1981.

5. It is brought to our notice that the applicant is retiring on 31-05-2024. It is thus evident that unless the decision is taken as about the treatment to be given to the suspension period undergone by the applicant his pension may not be finally determined. In the circumstances, following order is passed:

ORDER

[i] Respondent no.2 or whoever may be the competent authority, shall take decision in regard to the period of suspension undergone by the applicant whether or not shall be treated as the period spent on duty and also regarding pay and allowances to be paid to the applicant for the period of suspension, within two weeks from the date of this order and communicate its decision to the applicant.

[ii] Needless to state that if any grievance survives the applicant is not precluded from availing the appropriate remedy.
