- Though the Tribunal has passed the order on 2.7.2020, proper instructions are not obtained by the Ld. PO and affidavit in reply is also not filed. This is a case of transfer between complainant who is working as Assistant Commissioner of Foods at present at Nashik and who has moved this OA that he is to be sent back to his earlier posting at Zone-III, Vashi, Thane as his daughter who is 24 years is taking medical treatment for Blood Cancer as well as for Avascular Nerosis of Bylateral Hip Joint. Respondent no.4 who is at present posted at Zone-III, Vashi, Thane on the same post is required to be transferred if at all applicant is brought back. It is to be noted that earlier one Mr. Yashwant T. Daunde, Assistant Commissioner (Food), who was transferred from Zone X, Palghar, Thane to Kolhapur has challenged the said order dated 11.9.2019 of the Minister in OA No.912 of 2019. This Tribunal by its order dated 17.9.2019 has granted relief in his favour. Pursuant to the implementation of the said order the respondent Government has issued fresh order of transfer by giving the earlier post to Mr. Daunde and respondent no.4-Shri P.R. Singarwad. Thus by virtue of the said order Mr. Daunde was sent back to Zone X, Palghar, Thane and therefore the applicant who was working at Zone III is also transferred to Nashik.
- 3. After perusal of the said order it is made clear that the said order was qua applicant i.e. Daunde. In para 7 of

the said it was clearly mentioned, "as such prima facie the impugned transfer order qua applicant is not in consonance to Section 4(5) OF THE Act of 2005".
