1. Shri Punam Mahajan, learned Advocate for Applicant and Smt. K.S. Gaikwad, learned Presenting Officer for Respondents.

2. Learned Advocate for Applicant states that 'Suspension Order' dated 19.03.2024 against Applicant who belongs to cadre of 'District Social Welfare Officer-Class 1' was passed by 'Commissioner Social Welfare; Maharashtra State, Pune' on grounds which relate to earlier tenures of Applicant as (i) 'District Social Welfare ZP Latur' and (ii) 'District Social Welfare Department ZP Solapur'.

3. Learned Advocate for Applicant emphasized that 'Commissioner Social Welfare Maharashtra State, Pune' was neither 'Appointing Authority' nor 'Disciplinary Authority' for cadre of 'District Social Welfare Officer-Class 1' and was thus not competent to exercise power under 'Rule 4 (1)(a)' of 'MCS (D & A) Rules: 1979' to pass 'Suspension Order' dated 19.03.2024 against Applicant.

4. Learned Advocate for Applicant contended that about 6 Months have passed since 'Suspension Order' dated 19.03.2024 was passed against Applicant. Thus 'Suspension Review Committee' should have reviewed it; as otherwise it now stands revoked as per 'Judgment' of 'Hon'ble Supreme Court of India' in 'Ajay Kumar Chaudhari Vs. Union of India (2015) 7 SCC 291'.

5. Learned PO on the other hand draws attention to 'Memorandum' dated 09.07.2024 of 'Social Justice & Special Assistance Department' which is regarding confirmation of action taken by 'Commissioner Social Welfare, Maharashtra State, Pune' to issue 'Suspension Order' dated 19.03.2024 against Applicant.

6. Learned PO further draws attention to 'Para 6' of 'Short Affidavit-in-Reply' filed on 26.02.2024 to clarify that 'Commissioner of Social Welfare, Maharashtra State, Pune' had neither acted as 'Appointing Authority' nor 'Disciplinary Authority'; but only as 'Head of

Department' to issue 'Suspension Order' dated 19.03.2024 against Applicant; which is evident from contents of 'Memorandum' dated 09.07.2024 of 'Social Justice & Special Assistance Department.

7. The 'Suspension Order' dated 19.03.2024 issued against Applicant by 'Commissioner Social Welfare, Maharashtra State, Pune' was thus as 'Head of Department'. The grounds for passing 'Suspension Order' dated 19.03.2024 against Applicant relate to earlier tenures of Applicant as (a) 'District Social Welfare Officer ZP Pune', and (b) 'District Social Welfare Officer, ZP Solapur'.

8. The 'Suspension Order' dated 19.03.2024 issued against Applicant by 'Commissioner Social Welfare, Maharashtra State, Pune' mentions about various instances of 'Misconduct of Applicant' which are broadly of 'Administrative Nature' and 'prima facie' do not appear to be about 'Financial Irregularities' or 'Misappropriation of Funds' etc. Hence against this backdrop the 'Commissioner of Social Welfare, Maharashtra State, Pune' could have submitted report about 'Misconduct of Applicant' and sought 'Suspension Order' against Applicant from 'Appointing Authority' or 'Disciplinary Authority' instead of himself acting in haste as 'Head of Department'. Therefore in the aforesaid context and backdrop of 'Judgment' of 'Hon'ble Supreme Court of India in Ajay Kumar Chaudhari Vs. Union of India (2015) 7 SCC 291; the 'Principal Secretary Social Justice & Special Assistance Department' to immediately place case of Applicant before 'Suspension Review Committee' for appropriate decision as per provisions of 'Rule 4(5)(c)' of 'MCS (D & A) Rules 1979'.

9. The appropriate decision of 'Suspension Review Committee' regarding revocation or modification of 'Suspension Order' dated 19.03.2024 issued by 'Commissioner Social Welfare, Maharashtra State, Pune' or otherwise to be communicated within 'Two Weeks' to Applicant.
